

**ARGYLL AND BUTE COUNCIL
(COWAL HIGHLAND GATHERING)
(TEMPORARY TRAFFIC REGULATION) ORDER 2022**

Argyll and Bute Council in exercise of the powers conferred on them by Section 16(A) of the Road Traffic Regulation Act 1984, as amended and of all other enabling powers, being satisfied that traffic should be prohibited or restricted for the purpose of facilitating the holding of the Cowal Highland Gathering, and being otherwise satisfied that it is not reasonably practical for the event to be held otherwise than on a road, and having regard to the safety and convenience of alternative routes suitable for traffic which is affected by the Order, hereby make the following Order:

1. This Order may be cited as the “Argyll and Bute Council (Cowal Highland Gathering) (Temporary Traffic Regulation) Order 2022” and shall have effect, when indicated by signs, at the times and on the dates specified in the Schedules hereto.
2. The Interpretation Act 1978 shall apply for the interpretation of the Order as it applies for the interpretation of an Act of Parliament.
3. No person shall drive or cause or permit to be driven any vehicle through the length of road specified in the Schedule 1 to this Order.
4. No person shall cause or permit any vehicles to wait on the sections of road specified in Schedule 2 to this Order so as to facilitate the free flow of traffic.
5. No person shall cause or permit any vehicle to wait on the sections of roads specified in Schedule 3 to this Order so as to facilitate the free flow of traffic.
6. No person shall cause or permit any vehicle to drive otherwise than in the permitted direction of travel on the sections of road specified in Schedule 4 to this Order so as to facilitate the free flow of traffic.
7. No person shall cause or permit any vehicle to wait on the sections of roads specified in Schedule 5 to this Order so as to facilitate the free flow of traffic.
8. Item 6 in Schedule 7 of The Strathclyde Regional Council (Dunoon Town Centre) (Traffic Management) Order 1996 will be temporarily suspended between 0700 hours and 2200 hours on 27th August 2022, to permit two-way traffic in John Street between Victoria Road and Argyll Street.
9. The Police shall have power to direct the drivers of vehicles to park in any parking places, as circumstance requires. Vehicles parked in contravention of this Order may be subject to uplift and removal.
10. Nothing in this Order shall apply to any vehicle which is:-
 - (a) associated with the event;

- (b) being driven upon the direction or with the permission of a police constable in uniform;
- (c) being used in an emergency for coastguard, fire brigade, ambulance or police purposes.
