ARGYLL AND BUTE COUNCIL (SMITH DRIVE, CAMPBELTOWN) (TEMPORARY TRAFFIC MANAGEMENT) ORDER 2022

Argyll and Bute Council in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, (as substituted by the Road Traffic (Temporary Restrictions) Act 1991), and having complied with the Road Traffic (Temporary Restrictions) Procedure Regulations 1992, and being satisfied that traffic should be restricted or prohibited because of the likelihood of danger to the public hereby make the following Order:

Citation and commencement

1. This Order may be cited as the "Argyll and Bute Council (Smith Drive, Campbeltown)(Temporary Traffic Management) Order 2022" and will be effective, when indicated by signs from 0001 hours on the 17th of October 2022 to 2359 hours on the 16th of December 2022 or until the remedial works are complete, whichever is the earlier.

Prohibition on use of a road

Save as provided in Article 3 of this Order, no person shall drive or cause or permit to be driven any vehicle through the length of road specified in Schedule 1 to this Order when indicated by signs.

Exemptions

3. Nothing in Article 3 of this Order shall apply to any vehicle, which is being used for carrying out the works.

Prohibition on use of road

4. No person shall drive or cause or permit to be driven any vehicle, other than in the permitted direction of travel, when a prohibition is identified as applying to that length of road or parts of that length of road as specified Schedule 2 to this Order by means of one or more of the traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002.
