

**THE ARGYLL AND BUTE COUNCIL
(SPECIAL EVENT) (VARIOUS ROADS, HELENSBURGH)
(TEMPORARY PROHIBITION OF TRAFFIC)
ORDER 2024**

Argyll and Bute Council in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers, being satisfied that traffic on the length of road specified in the Schedule hereto should be prohibited or restricted for the purpose of facilitating the holding of the Babcock 10k Race in Helensburgh and having had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order, hereby make the following Order:

1. This Order may be cited as "The Argyll and Bute Council (Special Event) (Various Roads, Helensburgh) (Temporary Prohibition Of Traffic) Order 2024" and will be in operation between 1915 hours and 2100 hours on Thursday the Thirtieth day of May Two Thousand and Twenty Four.
2. The Interpretation Act 1978 shall apply for the interpretation of the Order as it applies for the interpretation of an Act of Parliament.
3. Subject to Article 4 of the Order, no person shall drive or cause or permit to be driven any vehicle through the length of road specified in the Schedule of this Order while this Order is in operation.
4. Nothing in this Order shall apply to any vehicle which is:
 - a) being driven upon the direction or with the permission of a police constable in uniform;
 - b) an emergency service vehicle.

Cardross Road	From outside the lodge to junction with Campbell Drive.
Campbell Drive	From junction with Cardross Road to junction with Kenilworth Avenue .
Kenilworth Avenue	From junction with Campbell Drive to junction with Ashton Drive.
Ashton Drive	To its junction with Waverley Avenue
Waverley Avenue	To Drumfork Road
Drumfork Road	From junction pedestrian footpath (Drumfork Road) to junction with Redgauntlet Road
Redgauntlet Road	From junction with Drumfork Road to junction with Old Luss Road
Old Luss Road	At junction with Redgauntlet Road and East King Street
East King Street	From junction with Old Luss Road to junction with Lomond Street
Grant Street	From junction with East King Street to junction with East Argyle Street
Sinclair Street	At junction with East /West Argyle Street
West Argyle Street	From junction with Sinclair Street to junction with Woodend Street
Woodend Street	From junction with West Argyle Street to junction with Rhu Road Higher

Castle Avenue	At junction with Rhu Road Lower (A814)
Cairndhu Avenue	From junction with Kidston Drive to junction with West King Street
West King Street	From junction with Cairndhu Avenue to junction with Colquhoun Street
Colquhoun Street	From junction with West King Street
Talisman Crescent	From junction with Redgauntlet Road to outside number 8 Talisman Crescent
