ROADS (SCOTLAND) ACT 1984

THE CITY OF EDINBURGH COUNCIL (MAYBURY ROAD, EDINBURGH) (REDETERMINATION OF MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE) ORDER 201_ RSO/19/12

The City of Edinburgh Council, in exercise of the powers conferred on them by section 1(1) and 152 (2) of the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf, hereby make the following Order:-

- 1. This Order may be cited as "The City of Edinburgh Council (Maybury Road, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) order 201_" and shall come into operation on the _ day of _ Two thousand _
- 2. The roads in the City of Edinburgh local government area specified in Schedule 1 to this Order, at present footway, shall become carriageway, the right of passage being exercisable by all classes of vehicle.
- 3. The roads in the City of Edinburgh local government area specified in Schedule 2 to this Order, at present footway, shall become verge, the right of passage being exercisable by foot only.

SCHEDULE 1

ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM FOOTWAY TO CARRIAGEWAY

Maybury Road

West side

- 1. All that part of the footway on the west side of Maybury Road 696 metres or thereby south of the intersection of the extended south kerbline of Pinegrove Gardens and the west kerbline of Maybury Road, southwards,
 - a) for a distance of 5 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby, then
 - b) for a distance of 22 metres or thereby and which has a width throughout of 2 metres or thereby and then
 - c) for a distance of 4 metres or thereby and which has a width that varies from 2 metres or thereby to 0 metres or thereby.

(marked 1 on the attached plan).

- 2. All that part of the footway on the west side of Maybury Road 162 metres or thereby south of the intersection of the extended south kerbline of Pinegrove Gardens and the west kerbline of Maybury Road, southwards,
 - a) for a distance of 5 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby, then
 - b) for a distance of 14 metres or thereby and which has a width throughout of 2 metres or thereby and then
 - c) for a distance of 5 metres or thereby and which has a width that varies from 2 metres or thereby to 0 metres or thereby.

(marked 4 on the attached plan).

- 3. All that part of the footway on the west side of Maybury Road 94 metres or thereby south of the intersection of the extended south kerbline of Pinegrove Gardens and the west kerbline of Maybury Road, southwards,
 - a) for a distance of 5 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby, then
 - b) for a distance of 19 metres or thereby and which has a width throughout of 2 metres or thereby and then
 - c) for a distance of 4 metres or thereby and which has a width that varies from 2 metres or thereby to 0 metres or thereby.

(marked 7 on the attached plan).

All as the lengths of roads are shown in sawtooth hatching on the plan annexed and executed as relative to the Order.

SCHEDULE 2

ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM FOOTWAY TO VERGE

Maybury Road

West side

- 1. All that part of the footway on the west side of Maybury Road 514 metres or thereby south of the intersection of the extended south kerbline of Pinegrove Gardens and the west kerbline of Maybury Road, southwards, for a distance of 169 metres or thereby and which has a width throughout of 2 metres or thereby. (marked 2 on the attached plan).
- 2. All that part of the footway on the west side of Maybury Road 200 metres or thereby south of the intersection of the extended south kerbline of Pinegrove Gardens and the west kerbline of Maybury Road, southwards, for a distance of 244 metres or thereby and which has a width throughout of 2 metres or thereby. (marked 3 on the attached plan).
- 3. All that part of the footway on the west side of Maybury Road 162 metres or thereby south of the intersection of the extended south kerbline of Pinegrove Gardens and the west kerbline of Maybury Road, southwards, for a distance of 5 metres or thereby and which has a width that varies from 2 metres or thereby to 0 metres of thereby. (marked 5 on the attached plan).
- 4. All that part of the footway on the west side of Maybury Road 118 metres or thereby south of the intersection of the extended south kerbline of Pinegrove Gardens and the west kerbline of Maybury Road, southwards,
 - a) for a distance of 4 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby, and then
 - b) for a distance of 33 metres or thereby and which has a width throughout of 2 metres or thereby.

(marked 6 on the attached plan).

All as the lengths of roads are shown in sawtooth hatching on the plan annexed and executed as relative to the Order.
