- 3. No person shall drive a motor vehicle at a speed exceeding 40 miles per hour on the lengths of road detailed in Schedule One to this Order and shown with a solid line or as described on the plan annexed and relative hereto at any time.
- 4. Except as set out in article 3 hereof the restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.


