

**THE DUMFRIES AND GALLOWAY COUNCIL
(WINDERMERE PARK, ANNAN)
(20 MILES PER HOUR SPEED LIMIT)
TRAFFIC REGULATION ORDER 2020**

The Dumfries and Galloway Council in exercise of their powers under section 84 of the Road Traffic Regulation Act 1984 and of all other powers and after consultation with the Chief Constable in accordance with Section 124 of that Act hereby make the following Order:

1. This Order may be cited as The Dumfries and Galloway Council, (Windermere Park, Annan) (20 Miles Per Hour Speed Limit) Traffic Regulation Order 2020 and shall commence on 10 January 2020.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. No person shall drive a motor vehicle at a speed exceeding 20 miles per hour on those roads detailed in Schedule One to this Order and constructed or to be constructed within the boundary shown in thick black broken line on the plan annexed and relative hereto at any time.
4. Except as set out in Article 3 hereof the restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.

This Order, together with the Schedule and Plan annexed hereto are executed for and on behalf of and as authorised by the Dumfries and Galloway Council by Laura Whitelaw, Solicitor and Proper Officer at Dumfries on 11 day of November, Two Thousand and Nineteen.

SCHEDULE ONE

20 MILES PER HOUR SPEED LIMIT

Description

Any road built or to be built, within the area delineated by thick black broken line on the Plan annexed and signed as relative hereto, the terminal point being indicated by speed restriction traffic signs as appropriate in accordance with the Traffic Signs Regulations and General Directions 2016.
