(VARIOUS ROADS) (VARIOUS SPEED LIMITS) TRAFFIC REGULATION ORDER NO. 2 1986

The Dumfries and Galloway Regional Council (hereinafter referred to as "the Council") in exercise of their powers under Section 84 of the Road Traffic Regulation Act 1984 and of all other powers and after consultation with the Chief Constable in accordance with Section 124(c) of that Act hereby make the following Order:-

1. This Order may be cited as the Dumfries and Galloway Regional Council (Various Roads) (Various Speed Limits) Traffic Regulation Order No. 2 1986 and will commence on
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. No person shall drive any motor vehicle on the lengths of road specified in the Schedule to this Order at a speed exceeding that specified in the said Schedule.
