The Dumfries and Galloway Regional Council (hereinafter referred to as "the Council") in exercise of their powers under Section 1(1) and (2) and Section 2(1) and (2) of the Road Traffic Regulation Act 1984 and in accordance with Section 124(1)(d) of that Act and after consultation with the Chief Constable in accordance with Section 124(1)(c) of that Act hereby make the following Order:-

1. This Order may be cited as the Dumfries and Galloway Regional Council (Waiting Restrictions Stranraer)(Various Roads) Order No 1 1980 Amendment Order 1994 and Dumfries and Galloway Regional Council (Waiting Restrictions, Stranraer)(Various Roads) Traffic Regulation Orders No 1 and 2 1985 Amendment Order 1994 and shall commence on 3 May 1994.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The Traffic Regulation Orders specified in Column One of the Schedule to this Order shall have effect subject to the amendments specified in Column Two of the said Schedule.
4. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 as aforesaid or by or under any other enactment.

Made and enacted by the Dumfries and Galloway Regional Council on the Twenty-Fifth day of January Nineteen Hundred and Ninety Four.

COLUMN TWO

Amendments

1a) Delete the whole of Article 3(b) and insert the following: " to wait between the hours of 8am and 6pm (Monday to Saturday inclusive) in any of the lengths of road specified in the Second Schedule to this Order for a continuous period of longer than 60 minutes or to return to park within 60 minutes of the last period of parking".

1b) In the "Second Schedule" delete "waiting restrictions to not more than 30 minutes in any period of one hour between 8am and 6pm" and insert the following:-
"60 minute limited waiting - no return within 60 minutes of the last period of parking (Monday to Saturday)."

2a) Delete the whole of Article 3(b)(i) and (ii) and insert the following: "to wait between the hours of 8am and 6pm (Monday to Saturday inclusive) on any of the lengths of road, specified in the Second Schedule to this Order for a continuous period of longer than 60 minutes or to return to park within 60 minutes of the last period of parking."

2b) In the "Second Schedule" delete "waiting restricted to not more than 30 minutes in any period of one hour between 8am and 6pm Monday - Saturday" and insert the following:-
"60 minute limited waiting - no return within 60 minutes of the last period of parking (Monday to Saturday)."

3a) Delete the whole of Article 4 and insert the following: "Save as provided for in Articles 6 and 7 of this Order no person except upon the direction or with the permission of a police officer in uniform, shall cause or permit any vehicle to wait between the hours of 8am and 6pm (Monday to Saturday) in any of the lengths of road specified in the Second Schedule to this Order for a continuous period of longer than 60 minutes or to return to park within 60 minutes of the last period of parking".

3b) In the "Second Schedule" delete "waiting restricted to not more than 30 minutes in any period of one hour between 8am and 6pm Monday - Saturday" and insert the following:-
"60 minute limited waiting - no return within 60 minutes of the last period of parking (Monday to Saturday)."
