**THE DUMFRIES AND GALLOWAY COUNCIL
(A701 AT HIDDEN CORNER, MOFFAT)
(REDETERMINATION OF MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE)
TRAFFIC REGULATION ORDER 2021**

The Dumfries and Galloway Council, in exercise of the powers conferred on them by sections 1(1) and 152(2) of the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf hereby make the following Order:

1. This Order may be cited as The Dumfries and Galloway Council (A 701 at Hidden Corner, Moffat) (Redetermination of Means of Exercise of Public Right of Passage) Traffic Regulation Order 2021, and shall come into force on 19 November 2021.
2. A701 at Hidden Corner, Moffat, specified in Schedule One to this Order and indicated by sawtooth hatching on the annexed Plan, at present a footway and footpath, shall become a cycle track, the right of passage being exercisable on pedal cycle and foot only.

This Order together with the Schedule and the Plan annexed hereto are executed on behalf of and as authorised by Dumfries and Galloway Council by Laura Whitelaw Solicitor and Proper Officer at Dumfries on 4th day of October Two Thousand and Twenty One.

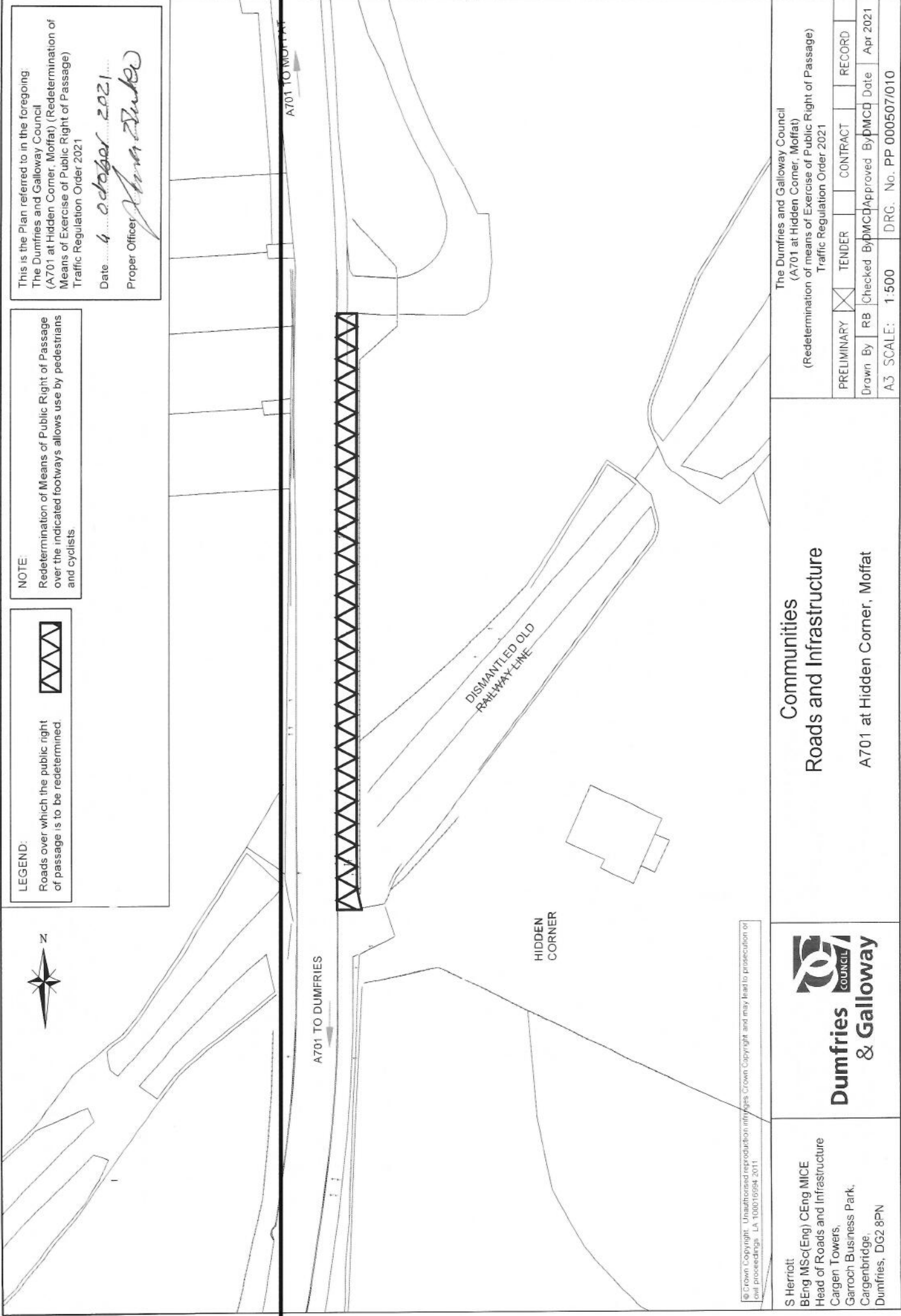
