

**THE EAST AYRSHIRE COUNCIL
(VARIOUS ROADS, BONNYTON AREA)
(20MPH SPEED LIMIT) AMENDMENT ORDER 201***

East Ayrshire Council, in exercise of the powers conferred on them by Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), as amended and of all other enabling powers and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. (a) This Order may be cited as "The East Ayrshire Council (Various Roads, Bonnyton Area) (20mph Speed Limit) Amendment Order 201*" and shall come into operation on *insert date*

2. (a) In this order the following expressions have the meanings hereby assigned to them-

"the Act" means the Road Traffic Regulation Act 1984.

"vehicle" means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power.

(b) A reference in this Order to any enactment is a reference to that enactment as amended by any subsequent enactment.

(c) A reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

3. The order specified in Schedule 1 to this order shall have effect subject to the amendments specified in that Schedule.

4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.

5. No person shall drive any motor vehicle at a speed exceeding 20mph on the length of roads specified in Schedule 1 to this Order.

	11. That length of Bailiehill Place from the extended east kerb line of Warwickhill Road eastwards for a distance of 68m or thereby.
	12. That length of Bellevue Road from the extended north kerb line of Bonnyton Road generally northwards for a distance of 262m or thereby. That length of the west link road fronting house numbers 14 to 38 Bellevue Road, for a distance of 86m or thereby.
	13. That length of Busbiehill Place from the extended east kerb line of Warwickhill Road eastwards for a distance of 129m or thereby.
	14. That length of Garrier Place from the extended north kerb line of Warwickhill Road north eastwards for a distance of 90m or thereby.
	15. That length of Robert Noble Place from the extended north kerb line of Warwickhill Road north eastwards for a distance of 65m or thereby.
	16. That length of Warwickhill Road from the extended north kerb line of Bonnyton Road north eastwards then westwards to the extended north kerb line of Bellevue Road for a distance of 385m or thereby. That length of the east spur between house numbers 14 and 16 Warwickhill Road for a distance of 23m or thereby.
