

EAST AYRSHIRE COUNCIL (VARIOUS ROADS, FISHER GRANGE/MOORFIELDS AND PORTLAND GAIT AREAS, KILMARNOCK)(20MPH SPEED LIMIT) ORDER 2015

East Ayrshire Council, in exercise of the powers conferred on them by Sections 1 and 84 of the Road Traffic Regulation Act 1984 ("the Act"), as amended and of all other enabling powers and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

Citation and Commencement

1. This Order may be cited as the **EAST AYRSHIRE COUNCIL (VARIOUS ROADS, FISHER GRANGE/MOORFIELDS AND PORTLAND GAIT AREAS, KILMARNOCK)(20MPH SPEED LIMIT) ORDER 2015** and shall come into operation on 23 February 2015.

Interpretation

2. a) In this Order the following expressions have the meanings hereby assigned to them:
- "the Act" means the Road Traffic Regulation Act 1984;
- "vehicle" means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power.
- b) A reference in this Order to any enactment is a reference to that enactment as amended by any subsequent enactment.
- c) A reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- d) No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.

Provisions

4. No person shall drive any motor vehicle at a speed exceeding 20mph on the lengths of road specified in Schedule 1 or shown on the Plan, both annexed and executed as relative hereto.
