(Route B741 near Connel Burn, New Cumnock) (Temporary Road Closure) Order 2019

East Ayrshire Council, in exercise of the powers conferred on it by Section 14(1) of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers, hereby makes the following Order—

PART I

GENERAL

Citation and commencement

1. This Order may be cited as “East Ayrshire Council (Route B741 near Connel Burn, New Cumnock) (Temporary Road Closure) Order 2019” and comes into force at 00:01 hours on Monday 18th February 2019 and will remain in force until 24:00 hours on Sunday 31st March 2019, by reason of works being executed on or near the road.

Interpretation

2. a) In this Order the following expressions have the meanings hereby assigned to them—

“Schedule” means the Schedule annexed and signed as relative hereto;

“vehicle” unless the context otherwise requires, means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power.

- b) A reference in this Order to any enactment is a reference to that enactment as amended by any subsequent enactment.
- c) A reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

PART II

RESTRICTED ACCESS

Road Closure

3. Save as provided in Articles 4, 5 and 6 no person shall drive or cause or permit to be driven any vehicle on any of the lengths of roads on the days and during the times specified in Schedule 1.

4. Nothing in Article 3 will apply so as to prevent any vehicle from being driven in any of the lengths of roads specified in Schedule 1 for as long as may be necessary to enable the vehicle to be used in pursuance of statutory powers and duties in connection with police, fire & rescue and ambulance purposes.
5. Nothing in Article 3 will apply so as to prevent any vehicle from being driven in any of the lengths of roads specified in Schedule 1 for as long as may be necessary to enable any vehicle being used in connection with the road realignment works to gain access to and egress from the site or to work within the site.
6. Nothing in Article 3 will apply so as to prevent any vehicle from being driven in any of the lengths of roads specified in Schedule 1 for as long as may be necessary to enable any vehicle to gain access to and egress from any property within the said roads but not through the works site.

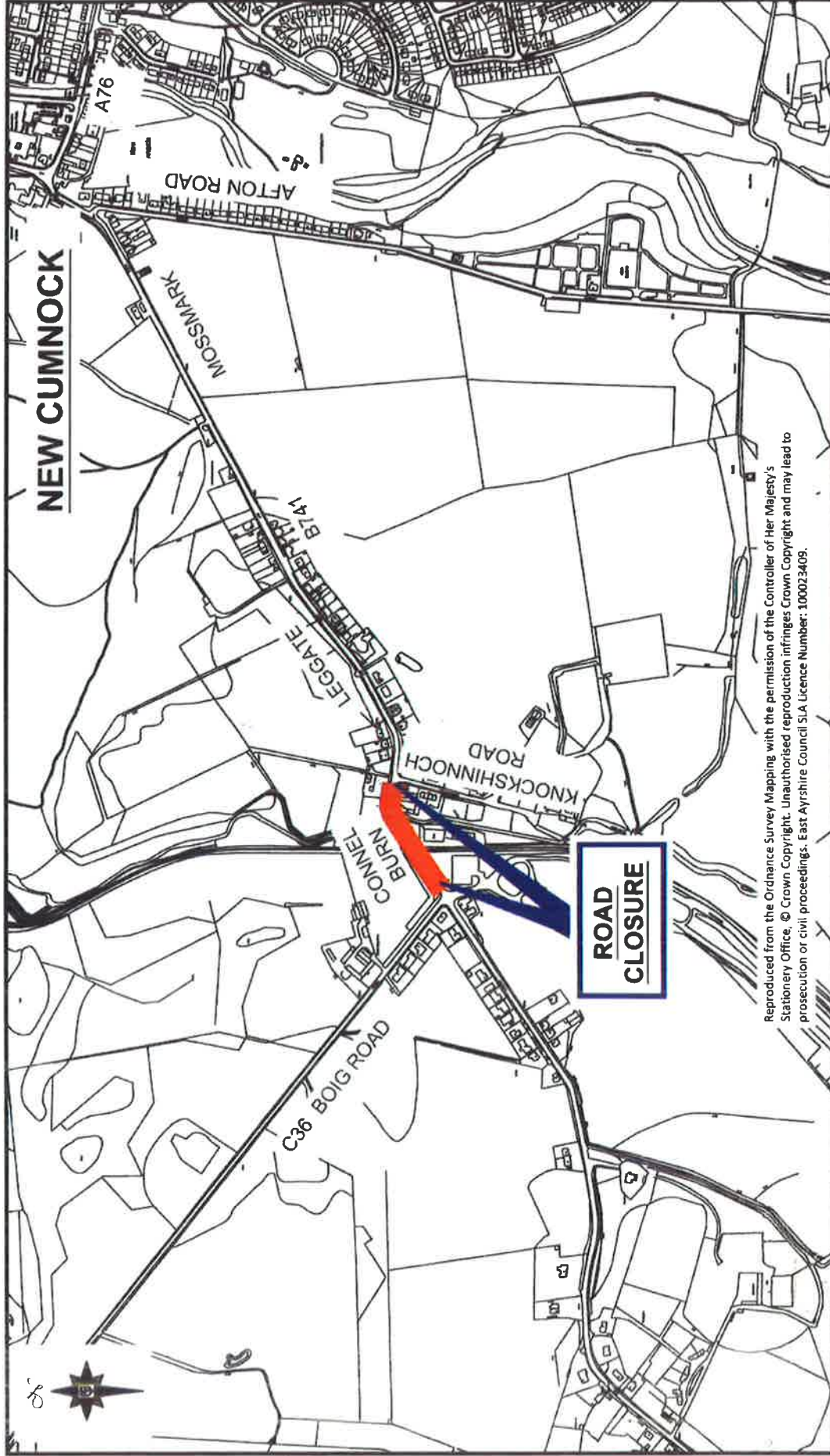
