THE EAST AYRSHIRE COUNCIL (VARIOUS ROADS, KNOCKENTIBER AND B751, CROSSHOUSE) (20 MPH AND 30 MPH SPEED LIMIT) (AMENDMENTS) ORDER 2019

East Ayrshire Council, in exercise of the powers conferred on it by Section 84(1) (a) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended and of all other enabling powers and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order.

PART I

GENERAL

Citation and Commencement

1. This Order may be cited as "East Ayrshire Council (Various Roads, Knockentiber and B751, Crosshouse) (20 MPH and 30 MPH Speed Limit) (Amendments) Order 2019" and shall come into operation on 16 September 2019.

Interpretation

- 2. (a) In this order the following expressions have the meanings hereby assigned to them-
 - "the 1984 Act" means the Road Traffic Regulation Act 1984.
 - "motor vehicle" unless the context otherwise requires, means a motor vehicle to include a mechanically propelled vehicle, intended or adapted for use on the road;
 - "Schedule" means the Schedule annexed and signed as relative hereto.
 - (b) A reference in this Order to any enactment is a reference to that enactment as amended by any subsequent enactment.
 - (c) A reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

PART II

Twenty Miles Per Hour Speed Limit

- 3. Save as provided in Article 4 it shall not be lawful for any person to drive a motor vehicle at a speed exceeding 20 MPH on any of the lengths of roads specified in Schedule 1.
- 4. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.

5. Save as provided in Article 4 it shall not be lawful for any person to drive a motor vehicle at a speed exceeding 30 MPH on any of the lengths of roads specified in Schedule 2.
