**EAST AYRSHIRE COUNCIL (B7083 MAIN STREET AUCHINLECK AND B7083 AUCHINLECK ROAD  
CUMNOCK) (REDETERMINATION OF MEANS OF EXERCISE OF PUBLIC  
RIGHT OF PASSAGE) ORDER 2020**

East Ayrshire Council in exercise of the powers conferred on them by Section 1(1) and Section 152(2) of the Roads (Scotland) Act 1984 and of all other powers enabling them in that behalf hereby make the following Order:

1. This Order may be cited as "East Ayrshire Council (B7083 Main Street, Auchinleck and B7083 Auchinleck Road, Cumnock) (Redetermination of Means of Exercise of Public Right of Passage) Order 2020" and shall come into operation on the 23 day of September 2020.
2. The roads in the areas of Auchinleck and Cumnock specified in the Schedule appended to and forming part of this Order, at present a footway, shall become a cycle track the right of passage being exercisable on pedal cycle and foot only.

### **LENGTHS OF ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE ARE TO BE REDETERMINED AS CYCLE TRACK**

#### **B7083 Main Street, Auchinleck**

The footway on the west side of Main Street from a point in line with the extended northwest kerblines of Rigg Road northwestwards for distance of 470m.

#### **B7083 Auchinleck Road, Cumnock**

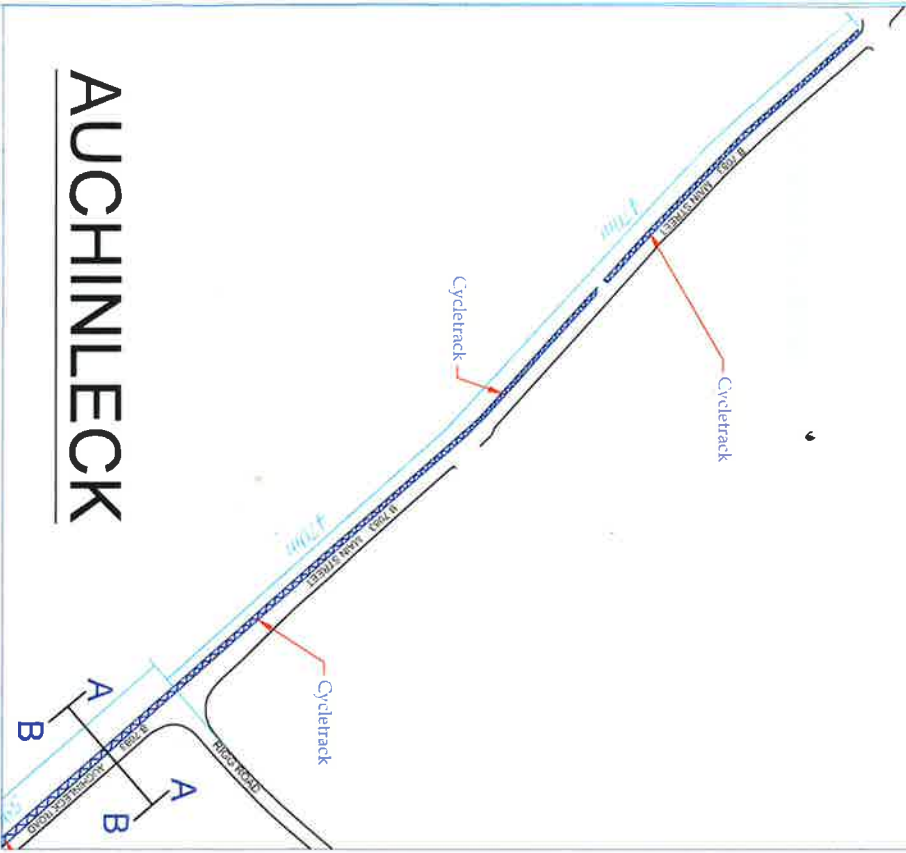
The footway on the west side of Auchinleck Road from the extended northern kerblines of Underwood Road northwestwards to a point in line with the extended northwest kerblines of Rigg Road (a distance of 590m or thereby)

All of which footways are shown saw tooth hatched on the plan (01) accompanying this Order.

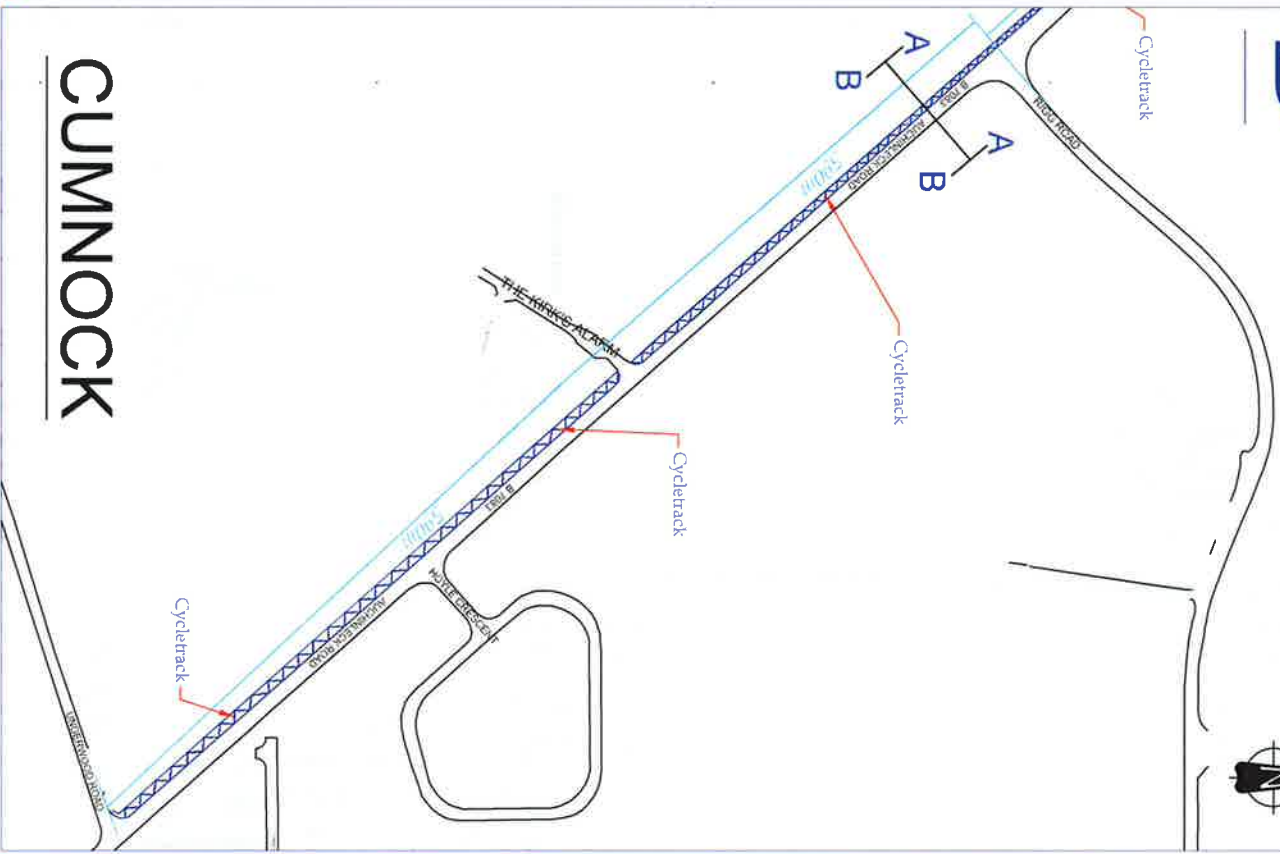
