

**East Ayrshire Council  
(Underwood Road, Cumnock)  
(Temporary 20mph Speed Limit) ORDER 2020**

East Ayrshire Council in exercise of the powers conferred on them by Section 14(1)(b) of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers, hereby makes the following Order :-

PART I

GENERAL

*Citation and commencement*

1. This Order may be cited as “*East Ayrshire Council (Underwood Road, Cumnock) (Temporary 20mph Speed Limit) Order 2020*” and shall come into operation at 08:00 hours on Thursday 29 October 2020 and will remain in operation until 17:00 hours on Sunday 17 April 2022, for reasons of road safety.

*Interpretation*

2. a) In this Order the following expressions have the meanings hereby assigned to them—  
  
"motor vehicle" unless the context otherwise requires, means a motor vehicle to include a mechanically propelled vehicle intended or adapted for use on the road;
- b) A reference in this Order to any enactment is a reference to that enactment as amended by any subsequent enactment.
- c) A reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order.

PART II

RESTRICTION

*Temporary 20mph Speed Limit*

3. Save as provided in Articles 4 and 5 no person shall drive any motor vehicle at a speed exceeding 20mph in the entire length of Underwood Road, Cumnock



(a distance of 225 metres or thereby) from 08:00 hours on Thursday 29<sup>th</sup> October 2020 until 17:00 hours on Sunday 17<sup>th</sup> April 2022

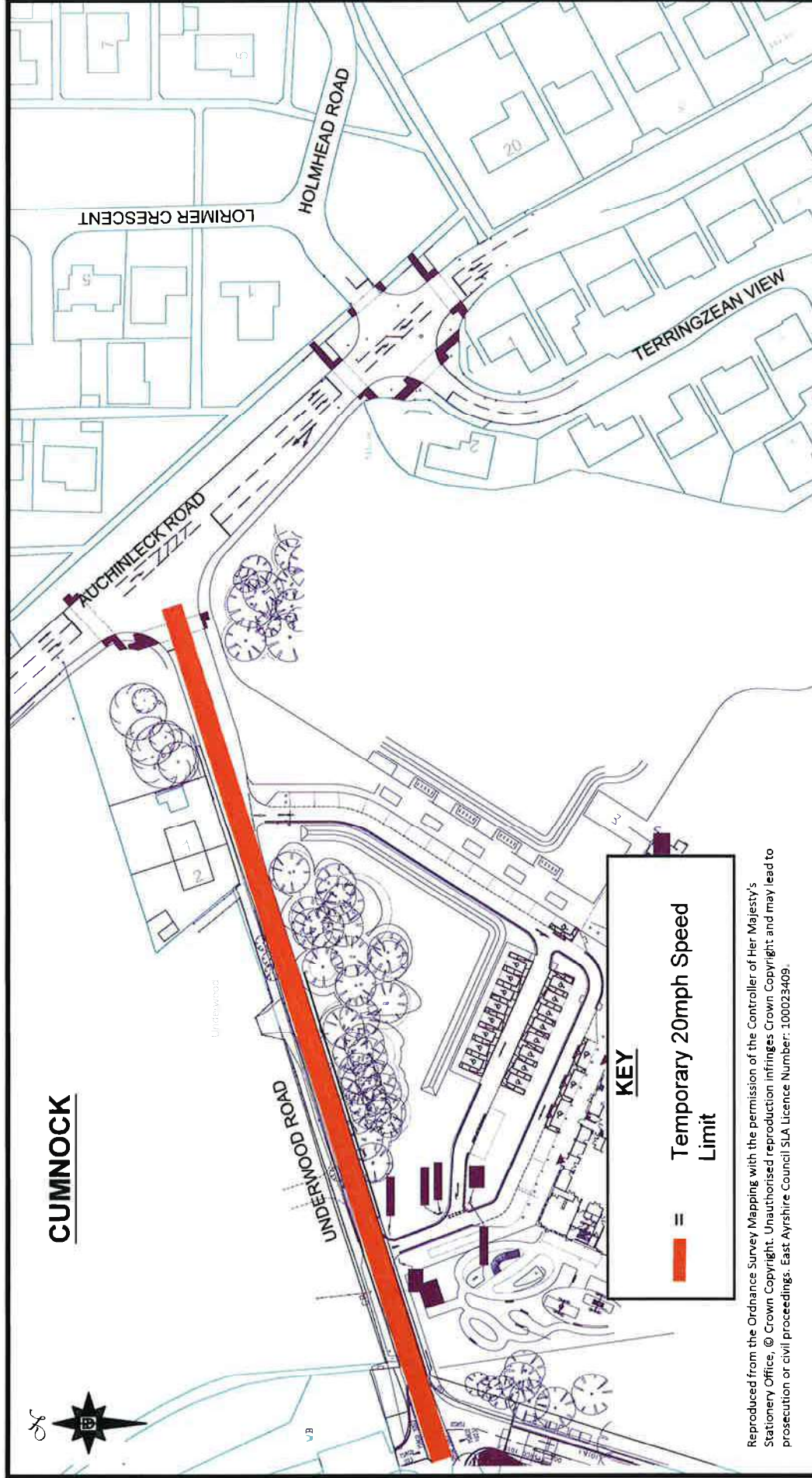
4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
5. The provisions of Article 3 shall apply only when—
  - a) speed limit signs in accordance with Diagram 670 of the Traffic Signs Regulations and General Directions 2016, as amended, are displayed on the affected length of road to denote the speed limit of 20mph
