**(WAITING AND LOADING RESTRICTIONS)(AMENDMENT) ORDER 2013**

East Ayrshire Council, in exercise of the powers conferred on them by Sections 1(1), 2(1), 2(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, the Road Traffic (Permitted Parking Area and Special Parking Area) (East Ayrshire Council) Designation Order 2012 and of all other enabling powers and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order—

***Citation and commencement***

1. This Order may be cited as “The East Ayrshire Council (Private Road Leading From London Road To Kay Park Church And Kilmarnock Bowling And Tennis Clubs, Kilmarnock)(Waiting And Loading Restrictions)(Amendment) Order 2013” and shall come into operation on 15 July 2013.

***Interpretation***

2. (a) A reference in this Order to any enactment is a reference to that enactment as amended by any subsequent enactment.  
  
(b) A reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.  
  
(c) The order specified in Schedule 1 to this order shall have effect subject to the amendments specified in that Schedule.

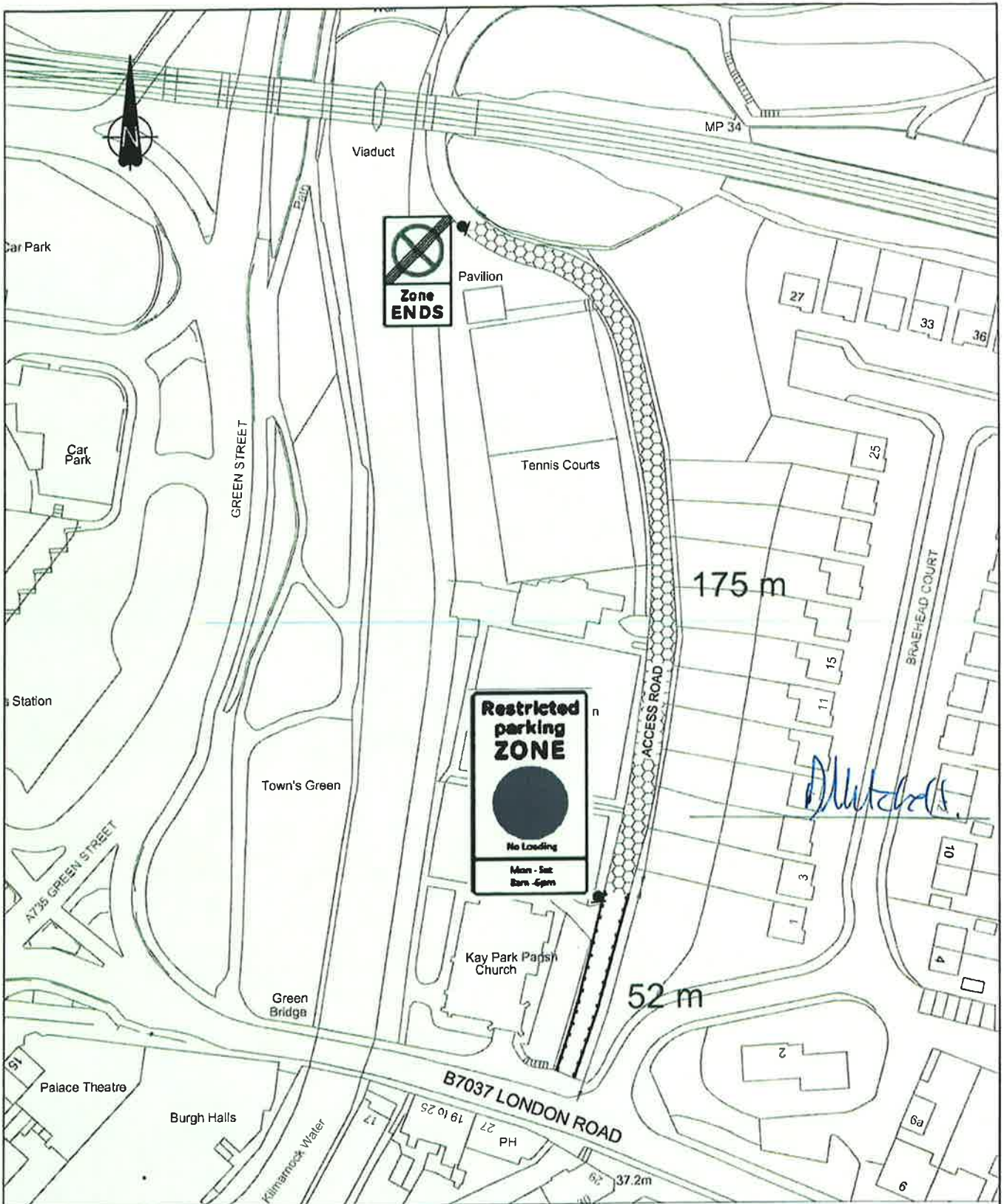
