

**EAST AYRSHIRE COUNCIL  
(BEANSBURN AND GREENHOLM STREET, KILMARNOCK) (PROHIBITION OF  
WAITING AND DISABLED PERSONS' DESIGNATED PARKING PLACE)  
(AMENDMENTS) ORDER 2016**

East Ayrshire Council, in exercise of the powers conferred on them by Sections 1(1), 2(1), 2(2), 4, 63A, 99, 101, 102 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, the Road Traffic (Permitted Parking Area and Special Parking Area) (East Ayrshire Council) Designation Order 2012 and Sections 66, 69, 70, 71, 72, 73, 74, 79 and Schedule 6 of the Road Traffic Act 1991, as amended, and of all other enabling powers and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order—

**PART I**

**GENERAL**

*Citation and commencement*

1. This Order may be cited as the “East Ayrshire Council (Beansburn and Greenholm Street, Kilmarnock) (Prohibition of Waiting and Disabled Persons’ Designated Parking Place) (Amendments) Order 2016” and shall come into operation on the 16<sup>th</sup> day of May 2016

*Interpretation*

2. In this Order unless the context otherwise requires—
  - (a) The following expression has this meaning hereby assigned to it—

“the 1984 Act” means the Road Traffic Regulation Act 1984;
  - (b) A reference in this Order to any enactment is a reference to that enactment as amended by any subsequent enactment.
  - (c) A reference in this Order to numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

*Order to be amended—*

3. The Order specified in Schedule 1 shall have effect subject to the amendments specified in that Schedule and as shown on Plans 2 and 23A annexed and executed hereto.
