(AMENDMENTS) ORDER 2019**

East Ayrshire Council, in exercise of the powers conferred upon them by Sections 1(1), 45, 46, 49, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, the Road Traffic (Permitted Parking Area and Special Parking Area)(East Ayrshire Council) Designation Order 2012, the Road Traffic Act 1991, as amended and of all other enabling powers and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 of the 1984 Act hereby make the following Order –

Citation and Commencement

1. This Order may be cited as the “East Ayrshire Council (Various Roads within East Ayrshire) (Waiting and Loading Restrictions and Designated Parking Places) (Amendments) Order 2019” and shall come into operation on the 7th day of October 2019

Interpretation

2. In this Order unless the context otherwise requires –
