Order 202-

East Ayrshire Council in exercise of the powers conferred on it by Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, and all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order—

PART I

GENERAL

Citation and commencement

This Order may be cited as “*East Ayrshire Council (Various Roads, Auchinleck and Cumnock) (20mph and 30mph Speed Limit and Revocation) Order 202-*” and shall come into force on the xx day of xx 202x.

Interpretation

1. In this Order the following expressions have the meanings hereby assigned to them—

“motor vehicle” unless the context otherwise requires, means a mechanically propelled vehicle intended or adapted for use on roads;

“the 1984 Act” means the Road Traffic Regulation Act 1984;

“Schedule” means Schedule 1, 2 and 3 annexed and signed as relative hereto.
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. A reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order unless otherwise stated.

PART II

SPEED LIMIT

4. Save as provided in Article 6 it shall not be lawful for any person to drive a motor vehicle at a speed exceeding 30mph on any of the lengths of roads specified in Schedule 1.
5. Save as provided in Article 6 it shall not be lawful for any person to drive a motor vehicle at a speed exceeding 20mph on any of the lengths of roads specified in Schedule 2.

6. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.

PART III

REVOCATION

7. The Orders specified in column 1 of Schedule 3 shall be revoked
