

**THE EAST AYRSHIRE COUNCIL
(ROUTE B778, THE CROSS TO LOUDOUN STREET, STEWARTON)
(RESTRICTED ROADS AND AMENDMENT) ORDER 2002**

East Ayrshire Council, in exercise of the powers conferred on them by Sections 82(2), 83(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended, and of all other enabling powers and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. This Order may be cited as "The East Ayrshire Council (Route B778, The Cross to Loudoun Street, Stewarton) (Restricted Roads and Amendment) Order 2002" and shall come into operation on Monday 25th November 2002.
2. a) In this Order the following expressions have the meanings hereby assigned to them—

"the Act" means the Road Traffic Regulation Act 1984.

b) A reference in this Order to any enactment is a reference to that enactment as amended by any subsequent enactment.

c) A reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
3. The lengths of roads specified in Schedule 1 to this Order shall become restricted roads for the purposes of Section 81(1) of the Act, which imposes a speed limit of 30 miles per hour on a restricted road.
4. The Order specified in Schedule 2 to this Order shall have effect subject to the amendments specified in that Schedule.

SCHEDULE 1

30 MPH SPEED LIMIT

Length of Road in the Local Authority Area of East Ayrshire

That length of the B778 in Stewarton which extends from its junction with A735 The Cross, Stewarton, southwards via Vennel Street, Holm Street, Kirkford and Loudoun Street to a point 120 metres east of the extended east edge of carriageway of the access road to Draffen Farm, Stewarton, a distance of 0.9 kilometres or thereby.
