**THE EAST AYRSHIRE COUNCIL
(ROUTES A735, B769 AND B778, STEWARTON)
(RESTRICTED ROADS AND AMENDMENT) ORDER 1999**

East Ayrshire Council, in exercise of the powers conferred on them by Sections 81(1), 82(2) and 83(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. This Order may be cited as "The East Ayrshire Council (Routes A735, B769 and B778, Stewarton) (Restricted Roads and Amendment) Order 1999" and shall come into operation on Monday 7th February 2000.
2. The lengths of roads specified in Schedule 1 to this Order shall become restricted roads for the purposes of Section 81(1) of the Act, which imposes a speed limit of 30 miles per hour on a restricted road.
3. The Order specified in Schedule 2 to this Order shall have effect subject to the amendments specified in that Schedule.

SCHEDULE 1

30 MPH SPEED LIMIT

Length of Road in the Local Authority Area of East Ayrshire

1. That length of the A735 in Stewarton which extends from a point 54 metres southwest of the extended southwest kerblineline of David Dale Avenue, Stewarton northwards via Lainshaw Street, The Cross, Rig Street and Dunlop Road to a point 110 metres north of the extended north kerblineline of Lamberton Road, Stewarton a distance of 1.1 kilometres or thereby.
2. That length of the B769 in Stewarton which extends from its junction with A735 at the Cross, Stewarton northeastwards via Main Street, High Street, Dean Street and Old Glasgow Road to a point 196 metres east of the extended west edge of carriageway of the access road to Holmhead Farm, Stewarton, a distance of 1.4 kilometres or thereby.
3. That length of the B778 in Stewarton which extends from a point 92 metres west of the extended northwest edge of carriageway of Kinloch Avenue, Stewarton eastwards and southeastwards via Dalry Road and Standalane to its junction with A735 Lainshaw Street, Stewarton, a distance of 0.8 kilometres or thereby.
4. That length of the B778 in Stewarton which extends from its junction with A735 The Cross, Stewarton, southwards via Vennel Street, Holm Street, Kirkford and Loudoun Street to a point 5 metres east of the extended east edge of carriageway of the access road to Draffen Farm, Stewarton, a distance of 0.8 kilometres or thereby.
