

**EAST AYRSHIRE COUNCIL**  
**(Various Roads, Hollybush, Waterside and B730 Coalhall to Drongan)**  
**(30mph and 40mph Speed Limits, and Amendments) ORDER 2024**

East Ayrshire Council in exercise of the powers conferred on it by Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, and all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:-

**Citation and Commencement**

  - (a) This Order may be cited as EAST AYRSHIRE COUNCIL (Various roads, Hollybush, Waterside and B730 Coalhall to Drongan) (30mph and 40mph Speed Limits, and Amendments) ORDER 2024 and shall come into operation on <date>.

**Interpretations**

2. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies to an Act of Parliament
3. In this Order the following expressions have the meanings hereby assigned to them—

“**motor vehicle**” unless the context otherwise requires, means a mechanically propelled vehicle intended or adapted for use on roads;

“**the Act**” means the Road Traffic Regulation Act 1984 as amended;

“**Schedule**” means Schedule 1, 2 and 3 annexed and signed as relative hereto.
4. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
5. A reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order unless otherwise stated.

**Provisions**

6. No person shall drive a motor vehicle at a speed exceeding 40mph on the lengths of road specified in Schedule 1 of this Order.
7. No person shall drive a motor vehicle at a speed exceeding 30mph on the lengths of road specified in Schedule 2 of this Order.
8. The Orders referred to within column 1 of Schedule 3 of this order shall be amended to the extent specified in column 2 of said schedule.

A713 Waterside

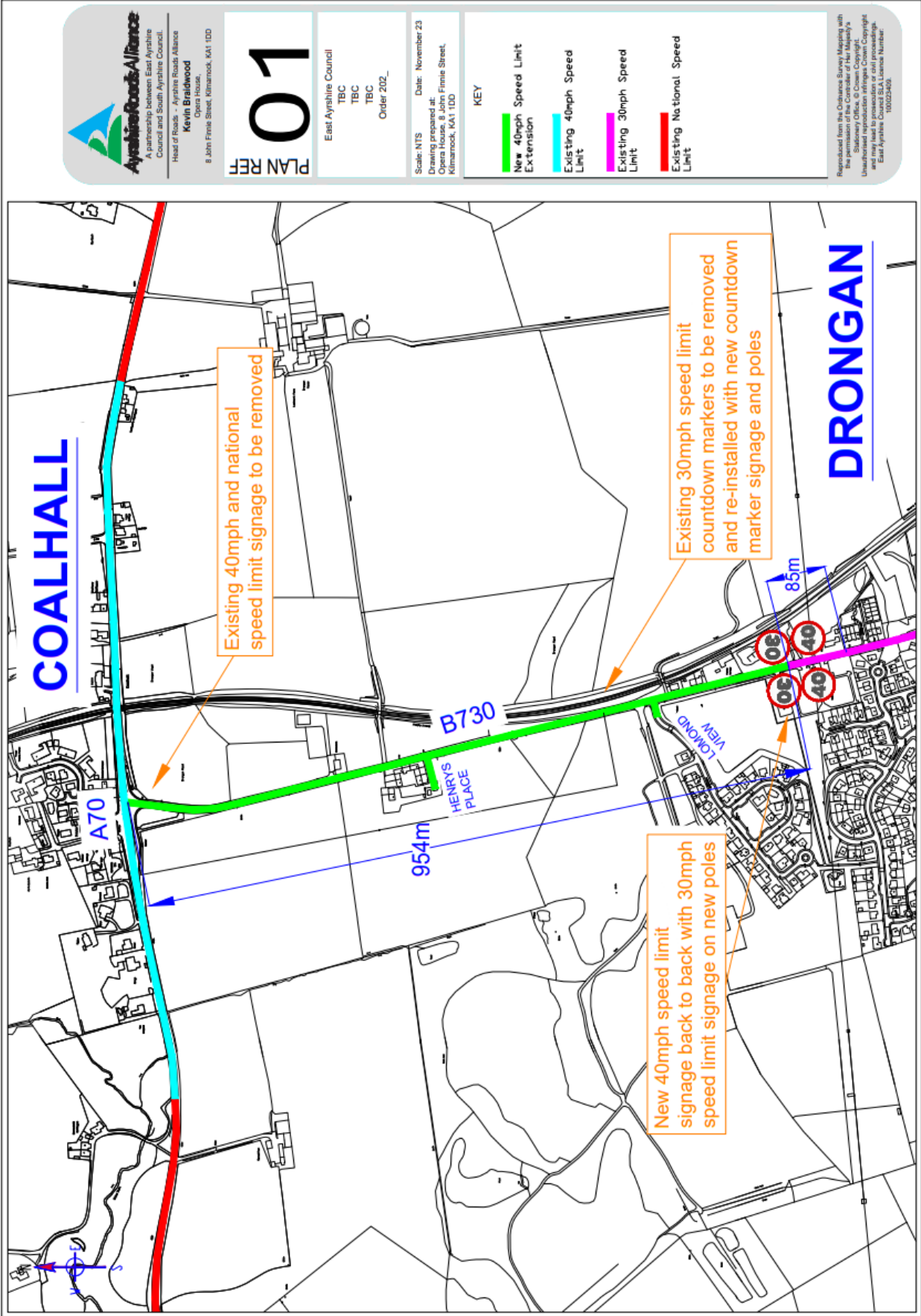
That length of the A713 Waterside which extends from a point 144 metres south-east of the extended eastern gable end of No. 10 Chapel Row, Waterside and which extends north-westwards for a distance of 1343 metres or thereby.

**30 mph Speed Limit**

| <b>Road Within The Boundary Of East Ayrshire Council</b> | <b>Extent of Affected Road</b>   |

| B7034 Clement Terrace                                    | That length of the B7034 Clement Terrace which extends from a point 58 metres south west of the extended western kerblineline of Hollybush Terrace generally north-eastwards leading to the A713 for a distance 372 metres or thereby. |
| Hollybush Terrace  | That length of Hollybush Terrace which extends from its junction with Clement Terrace for its entire length.   |
| Benston Crescent   | That length of Benston Crescent which extends from its junction with Clement Terrace for its entire length.  |
| Garden Court   | That length of Garden Court which extends from its junction with Clement Terrace generally eastwards for a distance of 123 metres or thereby.  |
