**EAST LoTHIAN COUNCIL (C122/C125 LAND AT INNERWICK JUNCTION,
DUNBAR)
STOPPING UP ORDER 2017
TO/ 003 / 17**

The East Lothian Council, in exercise of the powers conferred on them by section 68(1) of the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf, and having considered that the road specified in the Schedule to this Order will become unnecessary and being satisfied that a suitable alternative road is not necessary, hereby make the following Order:-

1. This Order may be cited as The East Lothian Council C122/C125 Land at Innerwick Junction, Dunbar Stopping Up Order 2017 and shall come into operation on the Twentieth Day of March 2017
2. The stopping up of the length of road in East Lothian Council specified in the Schedule to this Order is hereby ordered being all the part of the road described in that Schedule.
3. Where there is immediately before the date on which the said length of road is stopped up under this Order, any apparatus belonging to any statutory undertakers under, in, on, over, along or across the length of road for the purpose of carrying on their undertaking the said statutory undertakers shall after commencement of this Order continue to have all rights in respect of the said apparatus as they had immediately before that date.

This is the Schedule referred to in “the East Lothian Council (C122/C125 Land at Innerwick Junction, Dunbar) Stopping Up Order 2017

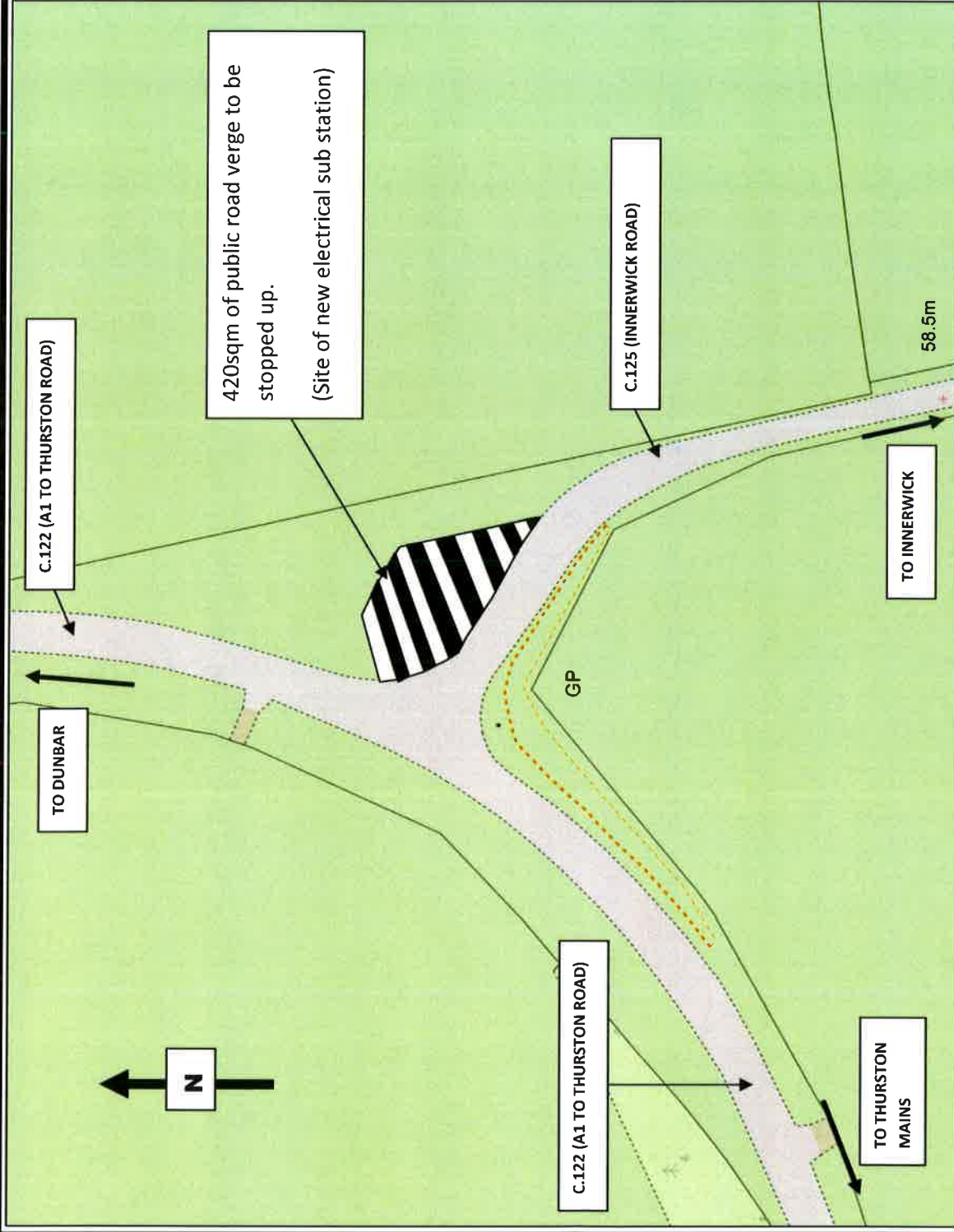
Part 1 Road to be Stopped Up

C122/C125 Junction: From a point 37 metres or thereby south east of the junction of the C122 and C125 in the north channel of the C125 in a north westerly then northerly direction following the radius of the junction for a distance of 41 metres or thereby and thereafter in a north easterly, easterly south easterly then southerly, parallel to the existing field boundary fence line (at the rear of the public road verge) to rejoin the north channel line of the C125 Innerwick Road.
Encompassing an area of road verge of 420sqm.

Part II Alternative Road

Alternative road not necessary

All as shown in zebra hatching on the plan (Drg No TO-003 / 17 / WL / 001) signed and sealed as relative to this Order.



C122/C125 LAND AT INNERWICK JUNCTION, DUNBAR

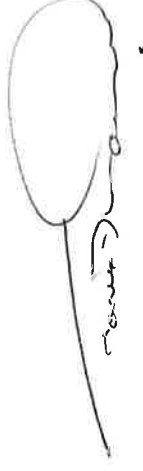
