
### EAST LoTHIAN COUNCIL (MUSSELBURGH RACECOURSE MEETINGS 2020) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2020

TO 001/20

EAST LoTHIAN COUNCIL in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984, as amended, and with the consent of the Scottish Ministers under section 16B(1)(b) and section 16B (6)(b), of the said Act and of all other enabling powers being satisfied that traffic on the lengths of roads specified in the Schedules hereto should be prohibited or restricted to facilitate various meetings at the Musselburgh Racecourse to enable members of the public to safely arrive, watch and leave any events and being satisfied that it is not reasonably practicable for the event to be held otherwise than at this location and having had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order, hereby make the following Order:-

1. This Order may be cited as the “East Lothian Council (Musselburgh Racecourse Meetings 2020) (Temporary Road Restriction and Traffic Regulation) Order 2020, shall come into operation on the First day of January, Two Thousand and Twenty and continue in force up to and including the Twenty Sixth of February Two Thousand and Twenty.
2. Save as provided in article 3 of this Order, to ensure the free flow of traffic in the vicinity of Musselburgh Racecourse, to accommodate the safe movement of pedestrians, to accommodate the safe movement of horses between Goose Green Stables and the Racecourse and to maintain a clear access route to and from the Racecourse for emergency vehicles during national hunt and flat race and trotting meetings held in Musselburgh, no person shall wait, load or unload a vehicle or cause or permit any vehicle to wait, or be loaded or unloaded between 8am and 10pm on any of the lengths of road specified in Schedule B to this order on any of the dates specified in Schedule A to this order. During the special Events specified in Schedule C to this order no through traffic is permitted for the lengths of road specified in Schedule D.
3. Nothing in article 2 of this Order shall prevent any person from waiting, loading or unloading a vehicle or causing or permitting any vehicle to wait or be loaded or unloaded on the parts of the roads specified in this Order if the vehicle is an emergency vehicle or is given the express permission of a police constable in uniform or a traffic warden. Nothing in Article 2 of this Order shall apply to vehicles displaying a disabled persons badge, or to coaches, television outside broadcast vehicles and news media vehicles associated with the race meeting and parked under police direction.
4. The prohibitions shall apply to both sides of the roads for their entire lengths unless specified otherwise. In addition to the dates specified in Schedule A, the prohibitions may have an effect also on any re-scheduled racing date within the duration of this Order.

James Street	Both sides for the entire length
Millhill	Both sides eastward from James Street to Linkfield Road
Balcarres Place	Both sides for the entire length
Balcarres Road	Both sides from Millhill to Goosegreen Crescent
Goosegreen Road	South side for the entire length
The Paddock (Part)	Both sides from Balcarres Place to Balcarres Road
Hope Place	South side for the entire length
Linkfield Road (Part)	Both sides from Loretto Corner to Musselburgh Main Street, on New Year's Day only
