

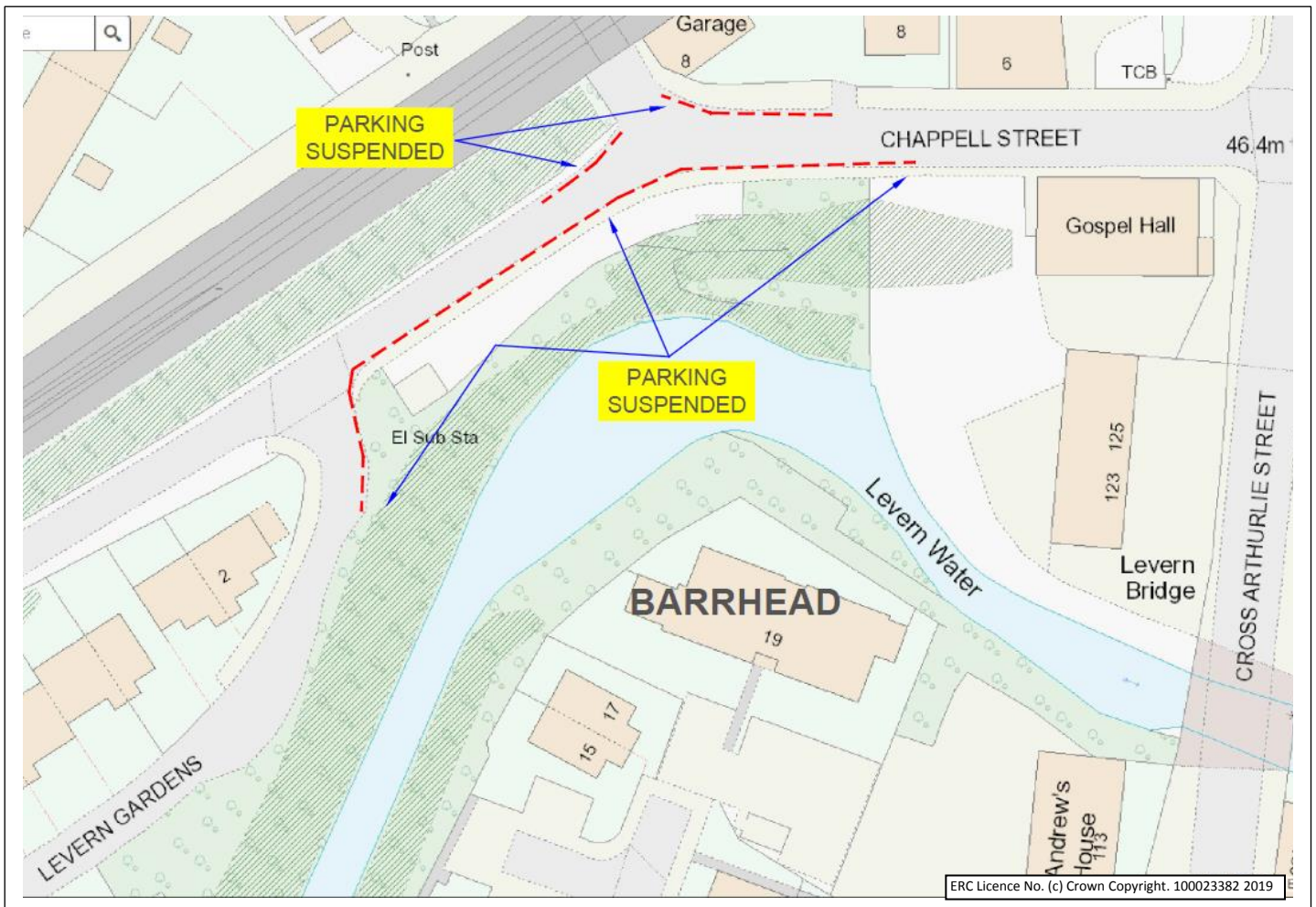
The East Renfrewshire Council
(Chappell Street and Levern Gardens, Barrhead)
(Temporary Restriction to Use of Road)
Order 2019



On the 7 June 2019 East Renfrewshire Council made the above named Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, in terms of which parking on the following roads, by the undernoted classes of vehicle will be prohibited when indicated by the appropriate Road traffic Sign.

(Note that the order will be in effect only when indicated by the display of appropriate signs in accordance with the Traffic Signs Regulations and General Directions 2016).

- Names of Roads:** CHAPPELL STREET AND LEVERN GARDENS, BARRHEAD
- Effects of the Restrictions:** TEMPORARY SUSPENSION OF PARKING (ONLY WHEN YELLOW 'NO WAITING' CONES ARE DISPLAYED)
- Reason for the Restrictions:** IN ORDER TO FACILITATE SAFE ACCESS FOR LARGE WORKS RELATED VEHICLES, INCLUDING MATERIAL DELIVERY VEHICLES, TO LAND ADJACENT TO CHAPPELL STREET IN CONNECTION WITH AN ESSENTIAL SEWER UTILITY SCHEME PLANNED TO BE COMMENCE ON OR NEAR THE ROAD.
- Extents of Restriction:** FROM A DISTANCE OF 45m WEST OF ITS JUNCTION WITH CROSS ARTHURLIE STREET FOR 40m OR THEREBY ON THE NORTHSIDE OF THE ROAD AND FOR 72m OR THEREBY ON THE SOUTHSIDE OF THE ROAD CONTINUING FOR APPROXIMATLEY 10m INTO LEVERN GARDENS.
- Duration of Restrictions:** WHILST THE ORDER WILL BE IN EFFECT FOR UP TO A MAXIMUM DURATION OF 18 MONTHS AS PERMITTED BY LEGISLATION THE WORKS ARE TO SCHEDULED TO COMMENCE ON 24 JUNE 2019 AND WILL TAKE APPROXIMATLEY 12 WEEKS TO COMPLETE, AND ONLY WHEN INDICATED BY APPROPRIATE SIGNAGE IN ACCORDANCE WITH THE TSRGD 2016
- Classes of Vehicle Restricted:** ALL - EXCEPT EMERGENCY VEHICLES WHILST ATTENDING AN INCIDENT AND VEHICLES ASSOCIATED WITH THE WORKS.
