(Temporary Restriction to Use of Road)**



Order 2019

On the 18 June 2019 East Renfrewshire Council made the above named Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, in terms of which parking on the following roads, by the undernoted classes of vehicle will be prohibited when indicated by the appropriate Road traffic Sign.

(Note that the order will be in effect only when indicated by the display of appropriate signs in accordance with the Traffic Signs Regulations and General Directions 2016).

| Max Duration of Restriction: | THE ORDER WILL BE VALID FOR A MAXIMUM PERIOD OF 18 MONTHS AS PRESCRIBED BY LEGISLATION. |
| Classes of Vehicle Restricted: | ALL - EXCEPT VEHICLES ASSOCIATED WITH THE WORKS AND EMERGENCY VEHICLES ATTENDING AN INCIDENT. ACCESS TO PROPERTIES WITHIN THE EXTENTS OF THE CLOSURE MAY BE PERMITTED BY THE CONTRACTOR ON SITE WHEN IT IS POSSIBLE TO DO SO IN CONJUNCTION WITH THE WORKS GOING ON AT THE TIME. |
| Alternative Routes: | BROOM ROAD EAST – WATERFOOT RD - MEARNS RD AND VICE-VERSA OR BROOMVALE DRIVE - AYR RD – SANDRINGHAM AVE – BROOM RD - MEARNS RD AND VICE-VERSA |
