(Uplawmoor Rd, Uplawmoor to Neilston)
(Temporary Restriction to Use of Road)
Order 2020

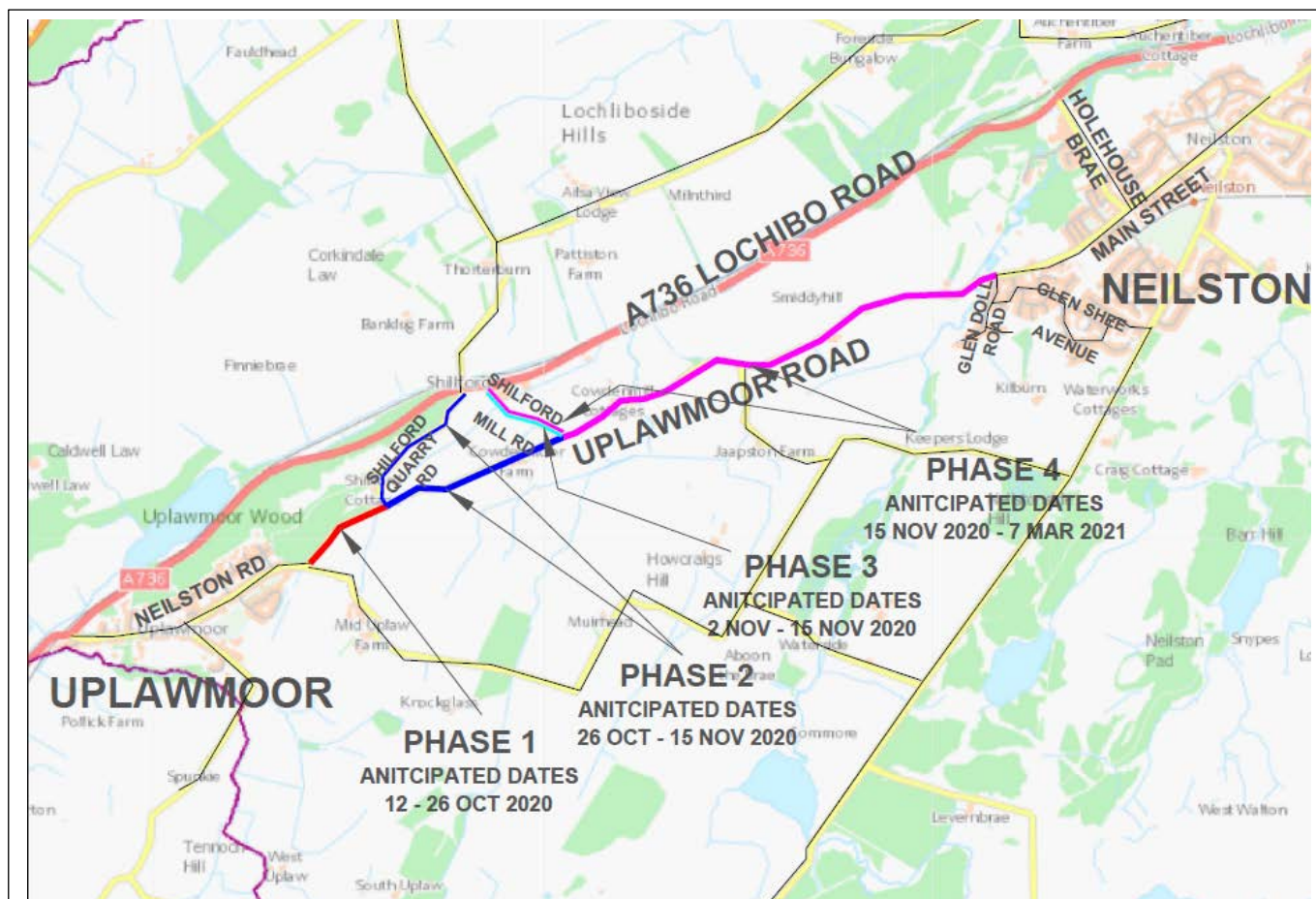


On the 24th September 2020 East Renfrewshire Council made the above named Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, in terms of which use of a section of the following road, by the undernoted classes of vehicle will be prohibited within the stated period of time.

(Note that the order will be in effect only when indicated by the display of appropriate signs in accordance with the Traffic Signs Regulations and General Directions 2016).

Effects of the Restrictions:	TEMPORARY ROAD CLOSURES
Roads affected:	UPLAWMOOR ROAD, BETWEEN UPLAWMOOR AND NEILSTON SHILFORD QUARRY ROAD, NEILSTON SHILFORD MILL ROAD, NEILSTON
Reason for the Restrictions:	TO FACILITATE THE INSTALLATION OF A NEW WATER MAIN ON OR NEAR THIS ROAD
Proposed Duration of Works:	MONDAY 12 OCTOBER 2020 UNTIL SUNDAY 7 MARCH 2021. (TO BE CARRIED OUT IN 4 PHASES)
Max Duration of Restrictions:	THE RESTRICTIONS AUTHORISED BY THIS ORDER REMAIN VALID FOR A MAXIMUM PERIOD OF 18 MONTHS FROM THE DATE THE ORDER WAS MADE, AS PRESCRIBED BY LEGISLATION.
Classes of Vehicle Prohibited:	ALL - EXCEPT VEHICLES ASSOCIATED WITH THE WORKS AND EMERGENCY VEHICLES ATTENDING AN INCIDENT. ACCESS TO PROPERTIES WITHIN THE EXTENTS OF THE CLOSURE MAY BE PERMITTED BY THE CONTRACTOR ON SITE WHEN IT IS POSSIBLE TO DO SO IN CONJUNCTION WITH THE WORKS GOING ON AT THE TIME. PEDESTRIAN ACCESS WILL BE MAINTAINED AT ALL TIMES.

Alternative Routes: UPLAWMOOR ROAD – MAIN STREET - HOLEHOUSE BRAE – A736 LOCHLIBO ROAD – NEILSTON ROAD AND VICEVERSA
