

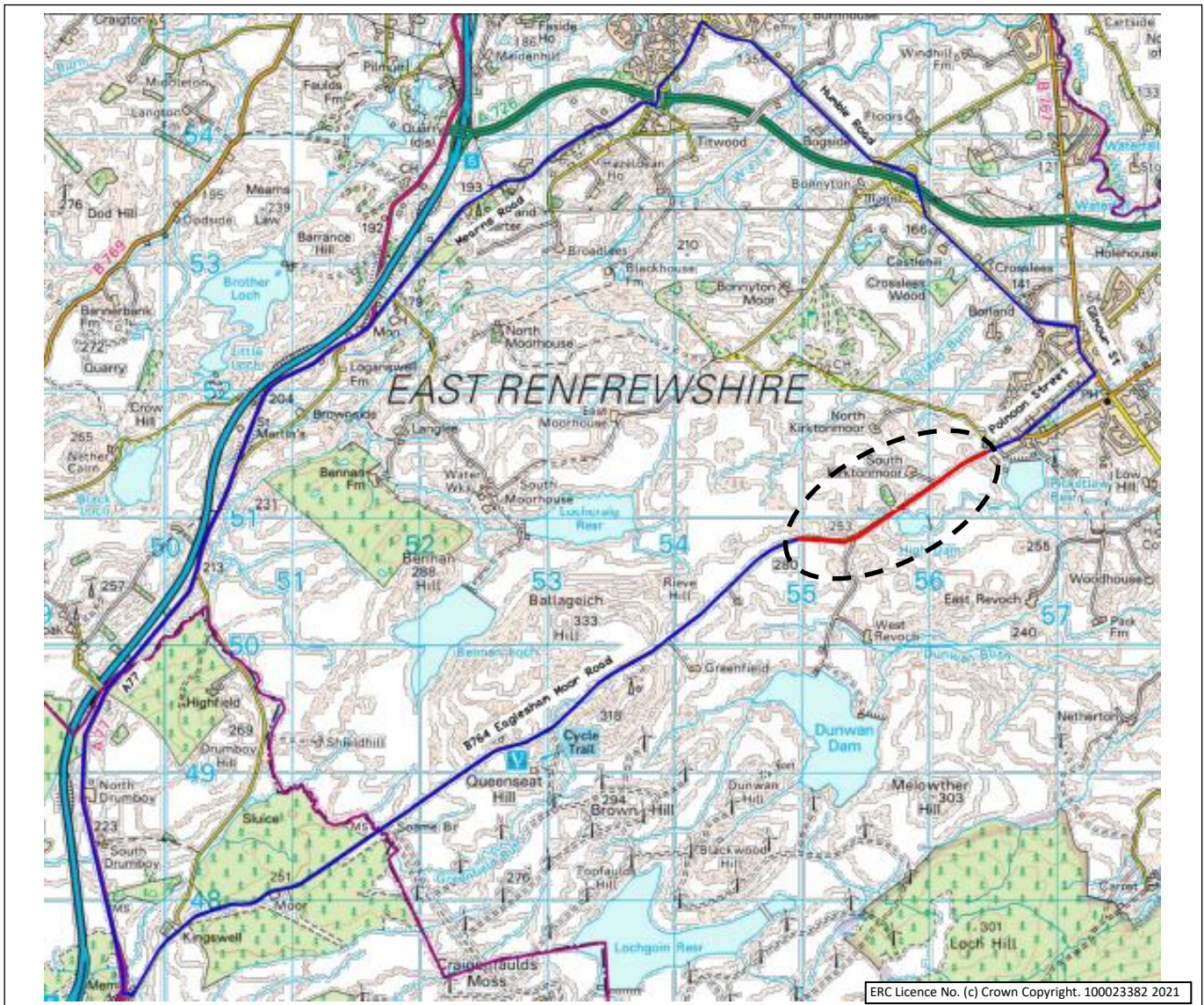
The East Renfrewshire Council
(B764 Eaglesham Moor Road, Eaglesham)
(Temporary Restriction to Use of Road)
Order 2021



On the 23 April 2021 the Council made the above named Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, in terms of which use of a section of the following road, by the undernoted classes of vehicle will be prohibited within the stated period of time.

(Note that the order will be in effect only when indicated by the display of appropriate signs in accordance with the Traffic Signs Regulations and General Directions 2016).

- Effects of the Restrictions:** TEMPORARY ROAD CLOSURE
- Roads affected:** B764 EAGLESHAM MOOR ROAD – FROM ITS JUNCTION AT KIRKTON MOOR ROAD SOUTH-WESTWARDS FOR A DISTANCE OF APPROX 1.8KM
- Reason for the Restrictions:** TO FACILITATE THE SAFE OPERATION OF ESSENTIAL CARRIAGEWAY RESURFACING WORKS
- Anticipated Duration of Works:** FROM SATURDAY 5 JUNE UNTIL SUNDAY 13 JUNE 2021
- Max Duration of Restrictions:** THE RESTRICTIONS AUTHORISED BY THIS ORDER WILL REMAIN VALID FOR A MAXIMUM PERIOD OF 18 MONTHS FROM THE DATE THE ORDER WAS MADE, AS PRESCRIBED BY LEGISLATION.
- Classes of Vehicle Prohibited:** ALL - EXCEPT VEHICLES ASSOCIATED WITH THE WORKS AND EMERGENCY VEHICLES ATTENDING AN INCIDENT. (NOTE: - ACCESS TO PROPERTIES WITHIN THE EXTENTS OF THE CLOSURE MAY BE PERMITTED BY THE CONTRACTOR ON SITE WHEN IT IS POSSIBLE TO DO SO IN CONJUNCTION WITH THE WORKS GOING ON AT THE TIME. PEDESTRIAN ACCESS WILL BE MAINTAINED AT ALL TIMES).
- Alternative Route:** B764 EAGLESHAM MOOR ROAD – A77 – MEARNS ROAD – HUMBIE ROAD – GILMOUR STREET – POLNOON STREET – B764 EAGLESHAM MOOR ROAD AND VICE-VERSA
