

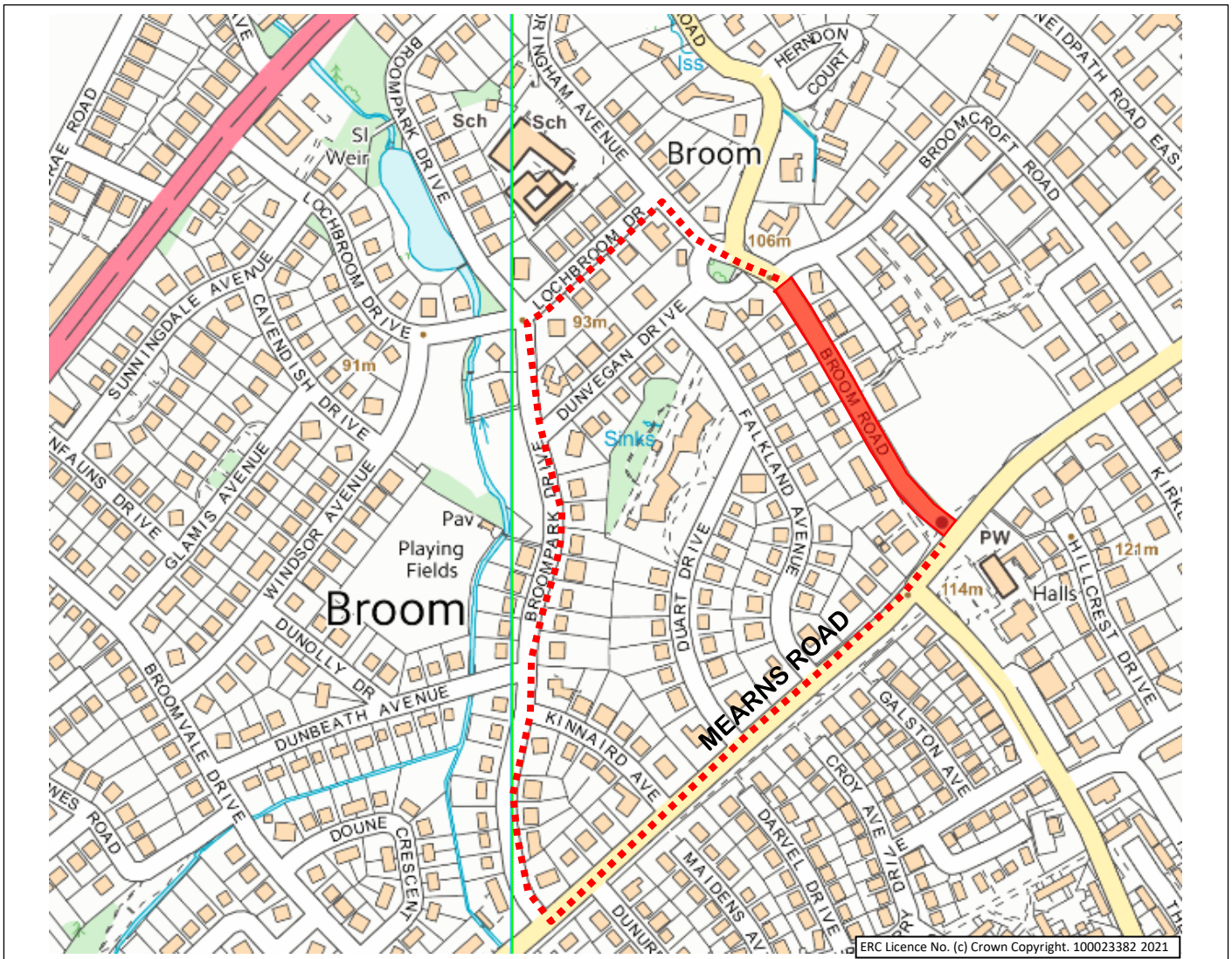
**The East Renfrewshire Council  
(Broom Road, Newton Mearns)  
(Temporary Restriction to Use of Road)  
Order 2021**



On the 24 September 2021 the Council made the above named Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, in terms of which use of a section of the following road, by the undernoted classes of vehicle will be prohibited within the stated period of time.

*(Note that the order will be in effect only when indicated by the display of appropriate signs in accordance with the Traffic Signs Regulations and General Directions 2016).*

<b>Effects of the Restrictions:</b>	TEMPORARY ROAD CLOSURE
<b>Road affected:</b>	BROOM ROAD – BETWEEN ITS JUNCTIONS WITH MEARNS ROAD AND BROOMCROFT ROAD.
<b>Reason for the Restrictions:</b>	TO FACILITATE THE SAFE OPERATION OF ESSENTIAL UTILITY WORKS WITHIN THE CARRIAGEWAY.
<b>Anticipated Duration of Works:</b>	FROM THURSDAY 28 OCTOBER UNTIL THURSDAY 13 JANUARY 2022.
<b>Max Duration of Restrictions:</b>	THE RESTRICTIONS AUTHORISED BY THIS ORDER WILL REMAIN VALID FOR A MAXIMUM PERIOD OF 18 MONTHS FROM THE DATE THE ORDER WAS MADE, AS PRESCRIBED BY LEGISLATION.
<b>Classes of Vehicle Prohibited:</b>	ALL - EXCEPT VEHICLES ASSOCIATED WITH THE WORKS AND EMERGENCY VEHICLES ATTENDING AN INCIDENT. (NOTE: - ACCESS TO PROPERTIES WITHIN THE EXTENTS OF THE CLOSURE MAY BE PERMITTED BY THE CONTRACTOR ON SITE WHEN IT IS POSSIBLE TO DO SO IN CONJUNCTION WITH THE WORKS GOING ON AT THE TIME. PEDESTRIAN ACCESS WILL BE MAINTAINED AT ALL TIMES).
<b>Alternative Route:</b>	BROOM ROAD – SANDINGHAM AVENUE – LOCHBROOM DRIVE – BROOMPARK DRIVE – MEARNS ROAD AND VICE-VERSA.
