### THE FALKIRK COUNCIL (BANK STREET, FALKIRK) (TEMPORARY ONE WAY TRAFFIC) (NO.TTRO/1012) ORDER 2017

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily reverse the permitted direction of travel by vehicles on Bank Street, Falkirk from 07:00 hours on 30/01/17 to 23:59 hours on 05/03/17. This is required to allow access by vehicles during the closure of Manor Street for essential works on behalf of Scottish Water.

Falkirk Council, in exercise of the powers conferred by Section 14(1) and (4) as read with Section 2(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, being satisfied that the traffic on the lengths of Road specified in the Schedule to this Order should be restricted or prohibited as hereinafter provided because works are being or are proposed to be executed on or near the said lengths, hereby make the following Order:-

**Citation, commencement and cessation**

- (1) This Order may be cited as "The Falkirk Council (Bank Street, Falkirk) (Temporary One way Traffic)(TTRO/1012) Order 2017" and shall come into force from 07:00 hours on 30/01/17 until 23:59 hours on 05/03/17 or until completion of the works, whichever is sooner.

**Interpretation**

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

**Temporary Restrictions on Use of a Road**

- (3) This order revokes in part article 5 of (The Falkirk Council) (Falkirk Town Centre) (Pedestrianisation and Associated Traffic Management) Order 1988 reversing temporarily the permitted direction of traffic on that section of road as specified in the Schedule of this Order.

**Exemption for Emergency and Works Vehicles**

- (4) Article 3 does not apply to a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes or a vehicle while being used for carrying out the works.
