THE FALKIRK COUNCIL (COW WYND, FALKIRK) (TEMPORARY PROHIBITION OF WAITING AND LOADING) (NO.TTRO/1013) ORDER 2017

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily prohibit waiting and loading on Cow Wynd, Falkirk from 07:00 hrs on 04/02/17 to 23:59 hrs on 12/03/17. The prohibition is to allow Scottish Water to safely install a new water main.

2. This order temporarily prohibits waiting and loading on both sides of Cow Wynd, Falkirk between it's junction with Booth Place and it's junction with Barnton Lane for a distance of 110 metres or thereby.

THE FALKIRK COUNCIL (COW WYND, FALKIRK) (TEMPORARY PROHIBITION OF WAITING AND LOADING) (NO.TTRO/1013) ORDER 2017

Falkirk Council, in exercise of the powers conferred by Section 14(1) and (4) as read with Section 2(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, being satisfied that the traffic on the lengths of Road specified in the Schedule to this Order should be restricted or prohibited as hereinafter provided because works are being or are proposed to be executed on or near the said lengths, hereby make the following Order:-

Citation, commencement and cessation

- (1) This Order may be cited as "The Falkirk Council (Cow Wynd, Falkirk) (Temporary Prohibition of Waiting and Loading) (TTRO/1013) Order 2017" and shall come into force from 07:00 hours on 04/02/17 until 23:59 hours on 12/03/17 or until completion of the works, whichever is sooner.

Interpretation

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Temporary Prohibition on Use of a Road

- (3) Subject to article 4, no person shall wait or load, or permit to wait or load, any vehicle on the length of Road and during the period(s) specified in the schedule when a prohibition is identified as applying to a part or parts of that length of road by means of one or more of the traffic signs prescribed in the Traffic Signs Regulations and General Directions 2016.

Exemption for Emergency and Works Vehicles

- (4) Article 3 does not apply to a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes or a vehicle while being used for carrying out the works.

Length of Road
Both sides of Cow Wynd, Falkirk between it's junction with Booth Place and it's junction with Barnton Lane for a distance of 110 metres or thereby.

Period of Prohibition:

From 07:00 hours on 04/02/17 to 23:59 hours on 12/03/17.

Statement of Reasons for Making the Order
