Falkirk Council in exercise of their powers under Section 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984, hereby make the following Order:-

1. This Order may be cited as "Falkirk Council (On-Street Parking Space for Disabled Persons) (No.58) Order 2001 and shall come into operation on the Eleventh day of October, Two Thousand and One.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The effect of this Order will be to designate the section of road described in the Schedule hereto and shown on the plan annexed and signed as relative hereto as a parking space for disabled persons' vehicles.
4. In this Order "disabled person's vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 1991;
