### **THE FALKIRK COUNCIL (FOOTPATH FROM HUNTER GARDENS TO BREWSTER PLACE, DENNY) (TEMPORARY PROHIBITION OF TRAFFIC) (NO.TTRO/1485) ORDER 2018**

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily prohibit pedestrians on the Footpath From Hunter Gardens To Brewster Place, Denny from 08.00 hours on 23/11/18 until 16:30 hours on 30/11/18. The prohibition is to ensure public safety during adjacent property maintenance works.

2. This Order temporarily closes the footpath from 35 Hunter Gardens in a westerly direction for approximately 17m.
3. The alternative route is: Footway 12m south of 12 Brewster Place, follow footway in a northerly direction for approximately 37m, continue on link footpath in a north easterly direction for approximately 12m, remain on link footpath in a easterly direction for approximately 39m, continue on footway 10m south of 20 Hunter Gardens in a southerly direction for approximately 35m and vice versa.

### **THE FALKIRK COUNCIL (FOOTPATH FROM HUNTER GARDENS TO BREWSTER PLACE, DENNY) (TEMPORARY PROHIBITION OF TRAFFIC) (NO.TTRO/1485) ORDER 2018**

Falkirk Council, in exercise of the powers conferred by Section 14(1) and (4) as read with Section 2(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, being satisfied that pedestrian traffic on the lengths of Footpath specified in the Schedule to this Order should be restricted or prohibited as hereinafter provided because works are being or are proposed to be executed on or near the said lengths, hereby make the following Order:-

#### **Citation, commencement and cessation**

- (1) This Order may be cited as "The Falkirk Council (Footpath From Hunter Gardens To Brewster Place, Denny (Temporary Prohibition of Traffic) (TTRO/1485) Order 2018" and shall come into force from 08.00 hours on 23/11/18 until 16:30 hours on 30/11/18 or until completion of the works, whichever is sooner.

#### **Interpretation**

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

#### **Temporary Prohibition on Use of a Road**

- (3) Subject to article 4, no person shall use the length of Footpath and during the period(s) specified in the schedule when a prohibition is identified as applying to a part or parts of that length of footpath by means of one or more of the traffic signs prescribed in the Traffic Signs Regulations and General Directions 2016.

#### **Exemption for Emergency and Works Vehicles**

- (4) Article 3 does not apply to a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes or a vehicle while being used for carrying out the works.

Footpath from 35 Hunter Gardens in a westerly direction for approximately 17m.

#### **Time of closure:**

08.00 hours on 23/11/18 until 16:30 hours on 30/11/18.

#### **Alternative Route:**

Footway 12m south of 12 Brewster Place, follow footway in a northerly direction for approximately 37m, continue on link footpath in a north easterly direction for approximately 12m, remain on link footpath in a easterly direction for approximately 39m, continue on footway 10m south of 20 Hunter Gardens in a southerly direction for approximately 35m and vice versa.
