### THE FALKIRK COUNCIL (B816 BRIDGE STREET, BONNYBRIDGE) (TEMPORARY PROHIBITION OF TRAFFIC) (TTRO/1526) ORDER 2019

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily prohibit vehicles on B816 Bridge Street, Bonnybridge from 22.00 hours on 11/02/19 until 06.00 hours on 14/04/19. The prohibition is to allow for bridge works.

2. This Order temporarily closes: B816 Bridge Street, from its junction with B816 Seabegs Road north bound for a distance of approximately 19 metres.

The alternative route is: B816 Seabegs Road, B816 Allandale Cottages, B816 Thorndale Gardens, B816 from Allandale to Maggies View, M80 at Castlecary, M80, M80 from northbound carriageway Junction 7 Haggs to 243m northwards from A803, includes off-slip, A80T from its junction with A803, Kilsyth Road northwards for a distance of 243m to M80, A803 Kilsyth Road, A803 Glasgow Road, A803 Bonnybridge Road, A803 Bonnyfield Road, A803 High Street, B816 Bridge Street and B816 Bridge Street, A803 High Street, A803 Bonnyfield Road, A803 Bonnybridge Road, A803 Glasgow Road, A803 Kilsyth Road, M80 southbound carriageway to A803 Kilsyth Road Junction 7 Haggs, M80 southbound slip at Junction 7 Haggs, M80, M80 from southbound carriageway to B816 at Junction 6A Castlecary, B816 from Allandale to Maggies View, B816 Thorndale Gardens, B816 Allandale Cottages, B816 Seabegs Road.

### THE FALKIRK COUNCIL (B816 BRIDGE STREET, BONNYBRIDGE) (TEMPORARY PROHIBITION OF TRAFFIC) (TTRO/1526) ORDER 2019

Falkirk Council, in exercise of the powers conferred by Section 14(1) and (4) as read with Section 2(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, being satisfied that the traffic on the lengths of Road specified in the Schedule to this Order should be restricted or prohibited as hereinafter provided because works are being or are proposed to be executed on or near the said lengths, hereby make the following Order:-

#### **Citation, commencement and cessation**

- (1) This Order may be cited as "The Falkirk Council (B816 Bridge Street, Bonnybridge) (Temporary Prohibition of Traffic) (TTRO/1526) Order 2019" and shall come into force from 22.00 hours on 11/02/19 until 06.00 hours on 14/04/19 or until completion of the works, whichever is sooner.

#### **Interpretation**

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

#### **Temporary Prohibition on Use of a Road**

- (3) Subject to article 4, no person shall use, or permit the use of, any vehicle on the length of Road and during the period(s) specified in the schedule when a prohibition is identified as applying to a part or parts of that length of road by means of one or more of the traffic signs prescribed in the Traffic Signs Regulations and General Directions 2016.

#### **Exemption for Emergency and Works Vehicles**

- (4) Article 3 does not apply to a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes or a vehicle while being used for carrying out the works.
