THE FALKIRK COUNCIL (VARIOUS STREETS, GRANGEMOUTH) (PUBLIC PROCESSION) (TEMPORARY PROHIBITION OF TRAFFIC) (TTRO/1529) ORDER 2019

Falkirk Council make the following Order, in exercise of the powers conferred by sections 2(1), 2(2), 4(1) and 16A of the Road Traffic Regulation Act 1984, and of all other powers enabling them to do so.

In accordance with Section 16A(2) of the 1984 Act, Falkirk Council are satisfied that traffic on the length(s) of road specified in the Schedule to this Order should be prohibited for the purpose of facilitating the holding of the public procession and enabling members of the public to watch this event.

In accordance with Section 16A (3) of the 1984 Act, Falkirk Council are satisfied that it is not reasonably practicable for the event to be held otherwise than on those length(s) of road.

In accordance with Section 16A (8) of the 1984 Act, Falkirk Council have had regard to the safety and convenience of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as "The Falkirk Council (Various Streets, Grangemouth) (Public Procession) (Temporary Prohibition of Traffic) (TTRO/1529) Order 2019" and shall come into force at 10.30 hours to 11.45 hours on 14/04/19.

Prohibition of use of vehicles

2. Subject to article 3, no person shall use, or permit the use of, any vehicle on the length(s) of road specified in the Schedule to this Order when such prohibition is identified as applying to any part or parts of the said length(s) of road by Police Officers in uniform.

Exemption for emergency and works vehicles

3. This Order does not apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance, or police purposes, or an official vehicle while being used in connection with the holding of the public procession.
