THE FALKIRK COUNCIL (MERCHISTON ROAD, FALKIRK) (WEIGHT RESTRICTION) ORDER 20__

FALKIRK COUNCIL in exercise of the powers conferred on it under Sections 1(1) to (3), 2(1) to (4) and 4(1) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, (hereinafter referred to as "the 1984 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. This Order may be cited as "The Falkirk Council (Merchiston Road, Falkirk) (Weight Restriction) Order 2019 and shall come into operation on the __ day of __, Two Thousand and __.
2. Save as provided in Article 3 of this Order, no person shall drive or cause or permit to be driven any vehicle upon any length of road specified in Column 1 of the Schedule to this Order if the maximum gross weight of the vehicle exceeds the weight specified in Column 2 to the said Schedule opposite the description of the said length of road and shown on the plans annexed and signed as relative to the Order.
3. Nothing in Article 2 of this Order shall prevent any person from causing or permitting any vehicle in excess of the permitted weight to proceed on the lengths of road specified in the Schedule to this Order if the vehicle is being used:-
 - (a) for the conveyance of persons, goods or merchandise to or from any premises situated in or adjacent to the said lengths of road;
 - (b) in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the length of road so referred to or the laying, erection, alteration, or repair in or near to the said length of road, of any sewer or any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunication apparatus as defined in sub-paragraph 1(1) of Schedule 2 to the Telecommunications Act 1984;
 - (c) for ambulance, fire brigade or police purposes or a motor vehicle in the service of a Local Authority being used in pursuance of statutory powers and duties;

- (d) for the purpose of agriculture in connection with land adjacent to the said lengths of road or for the conveyance or haulage of timber felled upon that land.

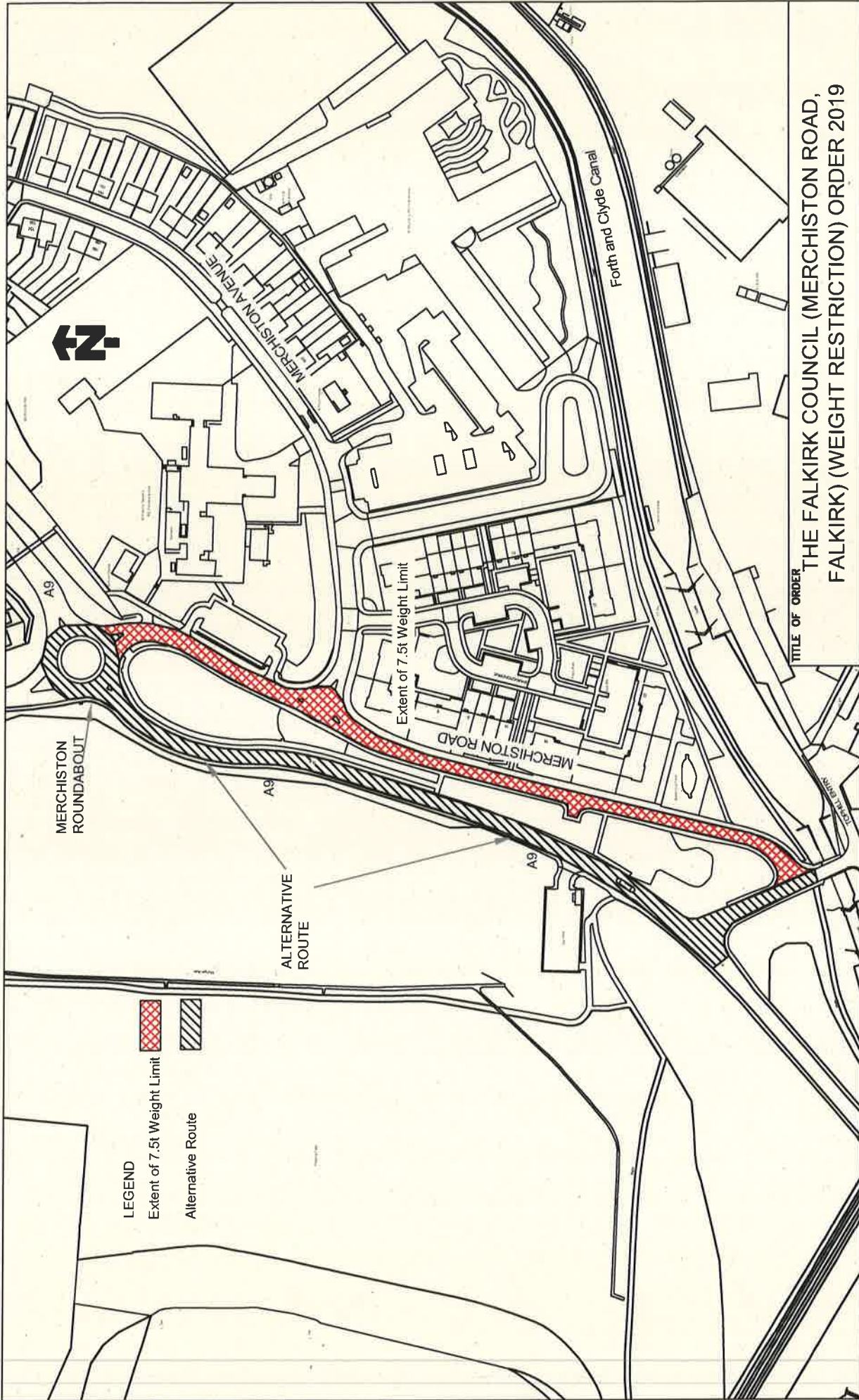
