THE FALKIRK COUNCIL (C12/20 GARVALD BURN, DENNY) (TEMPORARY PROHIBITION OF TRAFFIC) (NO.TTRO/1649) ORDER 2019

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily prohibit traffic on C12/20 Garvald Burn, Denny from 08.00 hours on 22/07/19 until 16.30 hours on 02/08/19. The prohibition is to allow for masonry works to the structure of this location.

2. This Order temporarily prohibits traffic on C12 at Greensburn Farm for a distance of 15m or thereabouts at the structure over Garvald Burn.
3. The alternative route is: C12 in a South Easterly direction until its junction with Myothill Road, continue on Myothill Road in an Easterly direction until its junction with the A872, continue on the A872 in a Northerly direction until its junction with the B818, continue on the B818 in a Westerly direction until its junction with Lawhill, continue on Lawhill in a Westerly direction until its junction with the C12, continue on the C12 and vice versa.

THE FALKIRK COUNCIL (C12/20 GARVALD BURN, DENNY) (TEMPORARY PROHIBITION OF TRAFFIC) (NO.TTRO/1649) ORDER 2019

Falkirk Council, in exercise of the powers conferred by Section 14(1) and (4) as read with Section 2(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, being satisfied that the traffic on the lengths of Road specified in the Schedule to this Order should be restricted or prohibited as hereinafter provided because works are being or are proposed to be executed on or near the said lengths, hereby make the following Order:-

Citation, commencement and cessation

- (1) This Order may be cited as "The Falkirk Council (C12/20 Garvald Burn, Denny) (Temporary Prohibition of Traffic) (TTRO/1649) Order 2019" and shall come into force from 08.00 hours on 22/07/19 until 16.30 hours on 02/08/19 or until completion of the works, whichever is sooner.

Interpretation

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Temporary Prohibition on Use of a Road

- (3) Subject to article 4, no person shall use, or permit the use of, any vehicle on the length of Road and during the period(s) specified in the schedule when a prohibition is identified as applying to a part or parts of that length of road by means of one or more of the traffic signs prescribed in the Traffic Signs Regulations and General Directions 2016.

Exemption for Emergency and Works Vehicles

- (4) Article 3 does not apply to a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes or a vehicle while being used for carrying out the works.

Alternative Route:

C12 in a South Easterly direction until its junction with Myothill Road, continue on Myothill Road in an Easterly direction until its junction with the A872, continue on the A872 in a Northerly direction until its junction with the B818, continue on the B818 in a Westerly direction until its junction with Lawhill, continue on Lawhill in a Westerly direction until its junction with the C12, continue on the C12 and vice versa.
