### **THE FALKIRK COUNCIL (ON-STREET PARKING SPACES FOR DISABLED PERSONS) (REVOCATION NO. 648) ORDER 2019**

Falkirk Council in exercise of their powers under the Road Traffic Regulation Act 1984, as amended (hereinafter referred to as "the 1984 Act") and of other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. This Order may be cited as "Falkirk Council (On-Street Parking Spaces for Disabled Persons)(Revocation No. 648) Order 2019" and shall come into operation on the 17 day of October, Two Thousand and Nineteen.
2. The following Order is hereby revokes The Falkirk Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Order 2018 insofar as it relates to the disabled persons parking bays located outside 6 Letham Cottages, Letham as indicated on plan AH26.
3. The effect of this Order will be to remove the designated sections of road described in the Schedule hereto as a parking space for disabled persons vehicles.

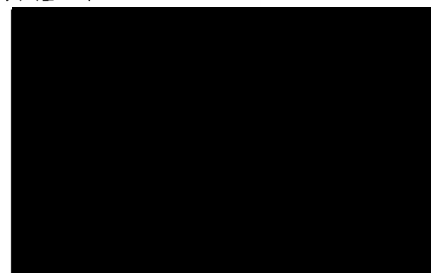

The Central Regional Council in exercise of their powers under Sections 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984, hereby make the following Order:-

1. This Order may be cited as "The Central Region (On-Street Parking Spaces for Disabled Persons) (No. 11) Order 1993" and shall come into operation on the Twelfth day of August, Nineteen Hundred and Ninety-three.
2. The effect of this Order will be to designate the section of road described in the Schedule hereto and shown on the plan annexed and signed as relative hereto as a parking space for disabled persons' vehicles.
3. In this Order "disabled person's vehicle" means a vehicle lawfully displaying a disabled person's badge issued, or having effect as if issued under any regulations for the time being in force under Section 21 of the Chronically Sick and Disabled Persons Act 1970.

On the north side thereof from a point 144 metres or thereby west of its junction with Waterslap Road in a westerly direction for a distance of 6 metres or thereby.




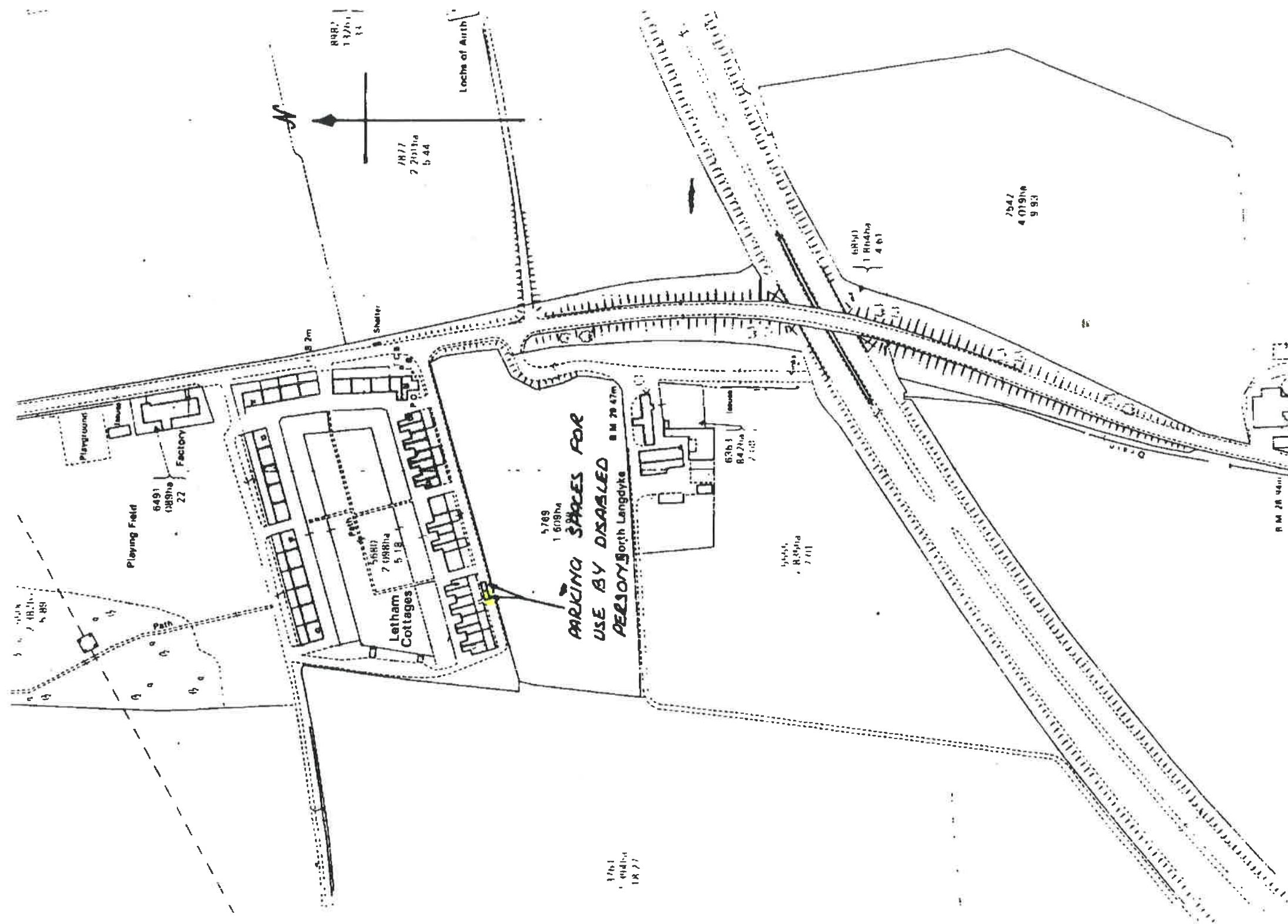
