THE FALKIRK COUNCIL (MILLENNIUM WHEEL DRIVE, CAMELON, FALKIRK) (PROHIBITION OF TRAFFIC)(TRO/19/021) EXPERIMENTAL ORDER 2019

Falkirk Council, hereinafter referred to as "the Council", in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984, hereby make the following Order:-

- 1. This Order may be cited as "The Falkirk Council (Millennium Wheel Drive, Camelon, Falkirk)(Prohibition of Traffic)(TRO/19/021) Experimental Order 2019 and shall come into operation on the 17 day of October, Two Thousand and Nineteen and shall be effective for a period of no more than eighteen months.
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
- 3. Save as provided in Articles 4, 5 and 6 of this Order no person shall, drive, or permit to be driven between the hours 9pm and 6am any motorised vehicle on the road specified in the Schedule to this Order.
- 4. Nothing in Article 3 of this Order will prevent any person driving or permitting to be driven any motorised vehicle on the road specified during the hours specified provided that such driving is solely for the purpose of removing the motorised vehicle from the road specified.
- 5. Nothing in Article 3 of this Order will prevent any person driving or permitting to be driven any motorised vehicle on the road specified and during the hours specified provided that such a motorised vehicle is being used in an emergency situation for fire brigade, ambulance, police or coastguard purposes or is in the service of a local authority, in either case being used in pursuance of statutory powers or duties.
- 6. Nothing in Article 3 of this Order will prevent any person driving or permitting to be driven any motorised vehicle on the road specified and during the hours specified provided that such a motorised vehicle is being used for the purpose of any building operation, demolition or excavation in or adjacent to the road specified or the maintenance, improvement or reconstruction of the road specified or the laying, erection, alteration, removal or repair in or adjacent to the road specified of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus as defined in subparagraph 1(1) of Schedule 2 to the Telecommunications Act 1984, as amended.
- 7. This Order will cease to have effect on the day eighteen months from the date of the making of the Order or on any earlier date which an authorised signatory of the Council may determine.


