more of the traffic signs prescribed in the Traffic Signs Regulations and General

Directions 2016.

Exemption for Emergency and Works Vehicles

(4) Article 3 does not apply to a vehicle while used in an emergency for Scottish Fire and

Rescue Service; Maritime and Coastguard Agency; Scottish Ambulance Service; or

Police Scotland purposes; or a vehicle whilst being used for carrying out the works.
