### **THE FALKIRK COUNCIL (A872 STIRLING ROAD, DUNIPACE) (40mph SPEED LIMIT) ORDER 2019**

Falkirk Council, in exercise of the powers conferred on it under Section 84 (1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended (hereinafter referred to as "the 1984 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. This Order may be cited as "The Falkirk Council (A872 Stirling Road, Dunipace) (40mph Speed Limit) Order 2019" and shall come into operation on the 9 day of January, Two Thousand and Twenty.
2. A speed limit of 40 miles per hour is hereby imposed on the lengths of road specified in Schedule 1 to this Order and shown on the attached plan. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the said lengths of road contained in Schedule 1.

## **SCHEDULE 1**

### **Roads in the Falkirk Council Area**

### **Section of Road over which a 40mph speed restriction is applicable**

**A872 Stirling Road, Dunipace**

From the existing 30/60mph speed limit interface, at a point 40 metres north of Ingleston Avenue, Dunipace, in a generally northerly direction for a distance of 300 metres or thereby.
