Order should be restricted or prohibited as hereinafter provided because works are being or

Citation, commencement and cessation

(1) This Order may be cited as "The Falkirk Council (Maggie Woods Loan, Falkirk)

(Temporary Prohibition of Traffic) (TTRO/1748) Order 2019" and shall come into force

from 09.00 hours on 12/12/19 until 18.00 hours on 20/12/19 or until completion of the

works, whichever is sooner.

Interpretation

(2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies

for the interpretation of an Act of Parliament.

Temporary Prohibition on Use of a Road

(3) Subject to article 4, no person shall use, or permit the use of, any vehicle on the

length of Road and during the period(s) specified in the schedule when a prohibition

is identified as applying to a part or parts of that length of road by means of one or

more of the traffic signs prescribed in the Traffic Signs Regulations and General

Directions 2016.

Exemption for Emergency and Works Vehicles

(4) Article 3 does not apply to a vehicle being used in an emergency for Scottish Fire

Rescue Service; Maritime and Coastguard Agency; Scottish Ambulance Service; or

Police Scotland purposes; or a vehicle whilst being used for carrying out the works.
