THE FALKIRK COUNCIL (ON-STREET PARKING SPACES FOR DISABLED PERSONS) (REVOCATION NO. 668) (TRO/19/035) ORDER 2019

Falkirk Council in exercise of their powers under the Road Traffic Regulation Act 1984, as amended (hereinafter referred to as "the 1984 Act") and of other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. This Order may be cited as "Falkirk Council (On-Street Parking Spaces for Disabled Persons)(Revocation No. 668) Order 2019" and shall come into operation on the 12 of March, Two Thousand and Twenty.
2. The following Order is hereby revokes The Falkirk Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Order 2018 insofar as it relates to the disabled persons parking space located outside 3 Avonside Drive, Dunipace as indicated on plan O33.
3. The effect of this Order will be to remove the designated sections of road described in the Schedule hereto as a parking space for disabled persons vehicles.

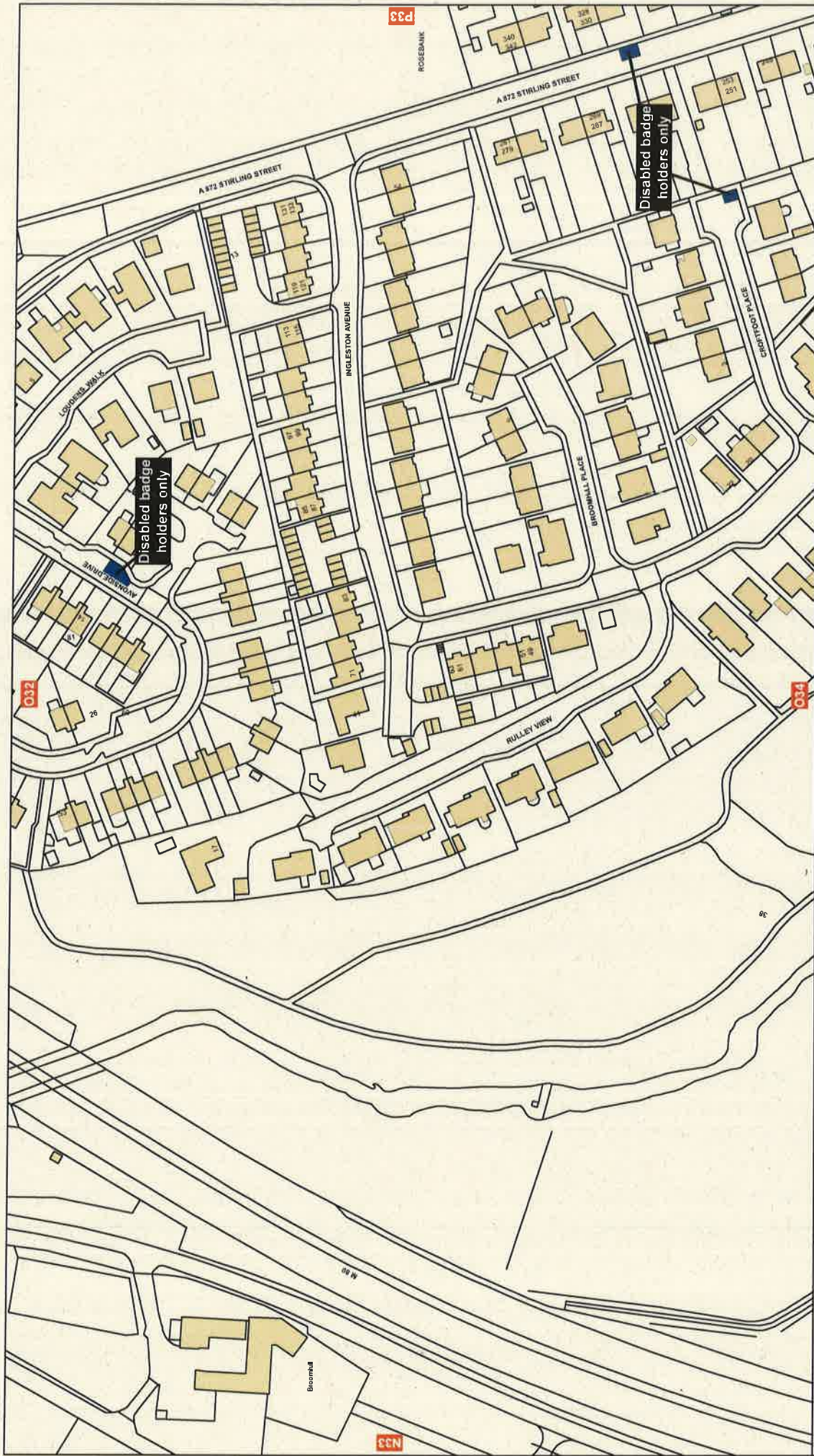
