- The following Order is hereby revokes The Falkirk Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Order 2018 insofar as it relates to the disabled persons parking space located outside 3 Avonside Drive, Dunipace as indicated on plan O33.
- The effect of this Order will be to remove the designated sections of road described in the Schedule hereto as a parking space for disabled persons vehicles.
