

## FALKIRK COUNCIL

### THE FALKIRK COUNCIL (C53 BOXTON ROAD, FALKIRK) (TEMPORARY PROHIBITION OF TRAFFIC) (TTRO/1778) ORDER 2020

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily prohibit vehicles on C53 Boxton Road, Falkirk from 08.00 hours on 23/03/20 until 23.59 hours on 20/04/20. The prohibition is to allow for repairs works by Scottish Water.

2. This Order temporarily closes: C53 Boxton Road, Falkirk, from its junction with B8028 from south boundary of California to Falkirk Road Avonbridge:-
  - (a) in a south westerly direction for approximately 1700m.
  - (b) in a north easterly direction for approximately 350m.
3. The alternative route is:
  - (a) B8028 from south boundary of California to Falkirk Road Avonbridge, B8028 Falkirk Road, B825 Slamannan Road, B825 Linlithgow-Caldercruix Road, B8022 from Avonbridge Road Slamannan via junction with Leppie Road to B825, C45 Leppie Road, C53 Boxton Road and vice versa
  - (b) C53 Boxton Road, B825 from Irene Terrace Standburn to Bowhouse Roundabout, B825 Irene Terrace, B825 Main Street, B825 Linlithgow-Caldercruix Road, B8028 Falkirk Road, B8028 from south boundary of California to Falkirk Road Avonbridge and vice versa

### THE FALKIRK COUNCIL (C53 BOXTON ROAD, FALKIRK) (TEMPORARY PROHIBITION OF TRAFFIC) (TTRO/1778) ORDER 2020

Falkirk Council, in exercise of the powers conferred by Section 14(1) and (4) as read with Section 2(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, being satisfied that the traffic on the lengths of Road specified in the Schedule to this Order should be restricted or prohibited as hereinafter provided because works are being or are proposed to be executed on or near the said lengths, hereby make the following Order:-

#### **Citation, commencement and cessation**

- (1) This Order may be cited as "The Falkirk Council (C53 Boxtan Road, Falkirk) (Temporary Prohibition of Traffic) (TTRO/1778) Order 2020 " and shall come into force from 08.00 hours on 23/03/20 until 23.59 hours on 20/04/20 or until completion of the works, whichever is sooner.

#### **Interpretation**

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

#### **Temporary Prohibition on Use of a Road**

- (3) Subject to article 4, no person shall use, or permit the use of, any vehicle on the length of Road and during the period(s) specified in the schedule when a prohibition is identified as applying to a part or parts of that length of road by means of one or more of the traffic signs prescribed in the Traffic Signs Regulations and General Directions 2016.

#### **Exemption for Emergency and Works Vehicles**

- (4) Article 3 does not apply to a vehicle being used in an emergency for Scottish Fire Rescue Service; Maritime and Coastguard Agency; Scottish Ambulance Service; or Police Scotland purposes; or a vehicle whilst being used for carrying out the works.

- (b) C53 Boxton Road, B825 from Irene Terrace Standburn to Bowhouse Roundabout, B825 Irene Terrace, B825 Main Street, B825 Linlithgow-Caldercruix Road, B8028 Falkirk Road, B8028 from south boundary of California to Falkirk Road Avonbridge and vice versa
