THE FALKIRK COUNCIL (ON-STREET PARKING SPACES FOR DISABLED PERSONS) (TRO/20/011) (REVOCATION NO. 703) ORDER 2020

Falkirk Council in exercise of their powers under the Road Traffic Regulation Act 1984, as amended (hereinafter referred to as “the 1984 Act”) and of other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. This Order may be cited as “Falkirk Council (On-Street Parking Spaces for Disabled Persons)(Revocation No. 703) Order 2020” and shall come into operation on the 8 day of October, Two Thousand and Twenty.
2. The following Order is hereby revokes The Falkirk Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Order 2018 insofar as it relates to the disabled persons parking spaces located close to 77 and 70 Valeview, Stenhousemuir as indicated on plan AB38.
3. The effect of this Order will be to remove the designated section of road described in the Schedule hereto as parking spaces for disabled persons vehicles.

	Locations of Parking Spaces for Disabled Persons Vehicles to be Removed
Valeview, Stenhousemuir	<p>On the north side of Valeview within the parking layby from a point 1 metre west of the projected east boundary line in a westerly direction for a distance of 7 metres or thereby.</p> <p>On the south side of Valeview from a point 3 metres east of the projected west boundary line of 70 Valeview in an easterly direction for a distance of 7 metres or thereby.</p>
