Falkirk Council in exercise of their powers under the Road Traffic Regulation Act 1984, as amended (hereinafter referred to as "the 1984 Act") and of other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

- 1. This Order may be cited as "The Falkirk Council (Grahams Road, Falkirk)(No Waiting at Any Time) (TRO/20/027) Order 2020" and shall come into operation on the 11 day of March, Two Thousand and Twenty one.
- The following Order hereby amends The Falkirk Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Order 2018 insofar as it relates to the waiting and loading restrictions located on Grahams Road, Falkirk as indicated on plan AF45.
- 3. The effect of this Order will be to replace the existing restrictions "Limited Waiting Mon Sat 9 am 6pm, 60 mins, No Return Within 1 Hour" with "No Waiting at Any Time" on the lengths of roads specified in Schedule 1.'


