### THE FALKIRK COUNCIL (NICOLTON ROAD, RUMFORD) (TEMPORARY PROHIBITION OF TRAFFIC) (NO.TTRO/1856) ORDER 2021

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily prohibit vehicles on Nicolson Road, Rumford from 08.00 hours on 16/09/2021 until 16.30 hours on 01/10/2021. The prohibition is to allow for the repairs of the 142330/40 Bridge.

2. This Order temporarily closes Nicolson Road at the 142330/40 Bridge, for approximately 20 metres on either side of the bridge. Specific location is 1000 metres south of the Lathallan Roundabout.
3. The alternative route is: Nicolson Road in a westerly direction then turn onto Carron Terrace, travel in a westerly direction then onto Maddiston Road, then travel in a northerly direction to the junction with Main Street, turn onto Main Street then travel in a easterly direction onto Station Road then travel in a northerly direction until the junction with the A803, turn onto the A803 Main Street and travel in a easterly direction to Lathallan roundabout before negotiating the roundabout and taking the A803 exit then turning into Nicolson Road then travelling in a southerly direction and vice versa. Local access will be maintained.

### THE FALKIRK COUNCIL (NICOLTON ROAD, RUMFORD) (TEMPORARY PROHIBITION OF TRAFFIC) (NO.TTRO/1856) ORDER 2021

Falkirk Council, in exercise of the powers conferred by Section 14(1) and (4) as read with Section 2(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, being satisfied that the traffic on the lengths of Road specified in the Schedule to this Order should be restricted or prohibited as hereinafter provided because works are being or are proposed to be executed on or near the said lengths, hereby make the following Order:-

#### **Citation, commencement and cessation**

- (1) This Order may be cited as "The Falkirk Council (NICOLTON ROAD, RUMFORD) (Temporary Prohibition of Traffic) (TTRO/1856) Order 2021" and shall come into force from 08.00 hours on 16/09/2021 until 16.30 hours on 01/10/2021 or until completion of the works, whichever is sooner.

#### **Interpretation**

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

#### **Temporary Prohibition on Use of a Road**

- (3) Subject to article 4, no person shall use, or permit the use of, any vehicle on the length of Road and during the period(s) specified in the schedule when a prohibition is identified as applying to a part or parts of that length of road by means of one or more of the traffic signs prescribed in the Traffic Signs Regulations and General Directions 2016.

#### **Exemption for Emergency and Works Vehicles**

- (4) Article 3 does not apply to a vehicle being used in an emergency for Scottish Fire Rescue Service; Maritime and Coastguard Agency; Scottish Ambulance Service; or Police Scotland purposes; or a vehicle whilst being used for carrying out the works.

<b>Length of Road</b>
Nicolton Road at the 142330/40 Bridge, for approximately 20 metres on either side of the bridge. Specific location is 1000 metres south of the Lathallan Roundabout.

**Time of closure:**

08.00 hours on 16/09/2021 to 16.30 hours on 01/10/2021.

**Alternative Route:**

Nicolton Road in a westerly direction then turn onto Carron Terrace, travel in a westerly direction onto Maddiston Road, then travel in a northerly direction to the junction with Main Street, turn onto Main Street then travel in a easterly direction onto Station Road then travel in a northerly direction until the junction with the A803, turn onto the A803 Main Street and travel in a easterly direction to Lathallan roundabout before negotiating the roundabout and taking the A803 exit then turning into Nicolton Road then travelling in a southerly direction and vice versa. Local access will be maintained.
