THE FALKIRK COUNCIL (FOOTPATH (NORTH) - A803 CAMELON ROAD, FALKIRK) (TEMPORARY FOOTPATH CLOSURE) (TTRO/2045) ORDER 2021

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily close the footpath (north) of A803 Camelon Road, Falkirk on 16/08/21 until 15/01/22. The closure is to facilitate adjacent property maintenance works.

2. This Order temporarily closes the footpath (north) of A803 Camelon Road from the junction of The Maltings in a westerly direction for a distance of 100 metres or thereby.
3. The alternative westbound route is A803 Camelon Road, B816 Glenfuir Road, A803 Main Street, A9 from Merchiston Roundabout to Rosebank Roundabout, A803 Camelon Road.
4. The alternative eastbound route is Road, A9 from Merchiston Roundabout to Rosebank Roundabout, A803 Main Street, B816 Glenfuir Road, A803 Camelon Road.

Falkirk Council, in exercise of the powers conferred by Section 14(1) and (4) as read with Section 2(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, being satisfied that pedestrian traffic on the lengths of footpath specified in the Schedule to this Order should be restricted or prohibited as hereinafter provided because works are being or are proposed to be executed on or near the said lengths, hereby make the following Order:-

Citation, commencement and cessation

- (1) This Order may be cited as "The Falkirk Council (Footpath (North) A803 Camelon Road, Falkirk) (Temporary Footpath Closure) (TTRO/2045) Order 2021" and shall come into force from on 16/08/21 until 15/01/22 or until completion of the works, whichever is sooner.

Interpretation

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Temporary Prohibition on Use of a Road

- (3) Subject to article 4, no person shall use the length of footpath and during the period(s) specified in the schedule when a prohibition is identified as applying to a part or parts of that length of footpath by means of one or more of the traffic signs prescribed in the Traffic Signs Regulations and General Directions 2016.

Exemption for Emergency and Works Vehicles

- (4) Article 3 does not apply to a vehicle being used in an emergency for Scottish Fire Rescue Service; Maritime and Coastguard Agency; Scottish Ambulance Service; or Police Scotland purposes; or a vehicle whilst being used for carrying out the works
