THE FALKIRK COUNCIL (ON-STREET PARKING SPACES FOR DISABLED PERSONS REVOCATION) (VARIOUS STREETS NO 5) ORDER 2022

Falkirk Council in exercise of their powers under the Road Traffic Regulation Act 1984, as amended (hereinafter referred to as "the 1984 Act") and of other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

- 1. This Order may be cited as "Falkirk Council (On-Street Parking Spaces for Disabled Persons Revocation)(Various Streets No 5) Order 2022" and shall come into operation on the 11 day of August, Two Thousand and Twenty Two.
- 2. This Order hereby revokes The Falkirk Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Order 2018 insofar as it relates to the disabled persons parking bays described in the schedule as indicated on plans listed in the schedule.
- 3. The effect of this Order will be to remove the designated sections of road described in the Schedule hereto as a parking space for disabled persons vehicles.

On the north side of Grange Drive from a point 2 metres west of the projected east building line of block 1-7 Grange Drive in a westerly direction for a distance of 13.2 metres or thereby.

On the north side of Balmoral Street from the projected west boundary line of 14 Balmoral Street in an easterly direction for a distance of 6.6 metres or thereby.

On the east side of Dundarroch Street from the projected north boundary line of 45 Dundarroch Street in a southerly direction for a distance of 6.6 metres or thereby.

On the northside of the parking court in Castlehill from the northeast end of the parking court adjacent to 32 Castlehill in a westerly direction for a distance of 3.6 metres or thereby.




Statement of Reasons for Making the Order


